Findings: We surveyed this uncataloged stream using baited minnow traps and GPS and captured juvenile coho salmon (Figure 1). The stream channel runs through a muskeg and the survey ended near the culvert; fish habitat may continue upstream (Table 1; Figures 2, 3).

Recommendations: Add this uncataloged stream to the anadromous waters catalog for rearing coho salmon (Figure 4).
