EXPLANATION:

This emergency order closes the Kuskokwim River drainage (excluding Kuskokwim Bay) to sport fishing for king salmon, effective 12:01 a.m. Sunday, May 1, 2016. In addition, only one unbaited, single-hook, artificial lure may be used in the Kuskokwim River drainage.

All king salmon caught unintentionally in the Kuskokwim River drainage while fishing for other species may not be removed from the water and must be released immediately.

REGULATION:

The provisions of 5 AAC 71.010. Seasons and bag, possession, annual, and size limits for the Kuskokwim-Goodnews Area. (c)(3)(A) are superseded and (c)(10) and (d)(1)(G) are added by this emergency order. Under this emergency order, the following provisions are effective, 12:01 a.m. Sunday, May 1 through 11:59 p.m. Monday, July 25, 2016:

5 AAC 71.010. Seasons and bag, possession, annual, and size limits for the Kuskokwim-Goodnews Area.

(c)(3)(A) sport fishing for king salmon is closed; king salmon may not be taken or possessed.

(c)(10) in the Kuskokwim River drainage, sport fishing for king salmon is closed; king salmon may not be taken or possessed.

(d)(1) only one unbaited, single-hook, artificial lures may be used in the (G) remainder of the Kuskokwim River drainage not specified in (d)(1)(A-F).

JUSTIFICATION:

Preseason projections suggest that the Kuskokwim River king salmon run in 2016 may be similar to 2015 when the Kuskokwim River experienced an estimated total run of approximately 158,000 and spawning escapement of approximately 138,000 fish. In 2015, the drainagewide escapement goal was achieved and exceeded the upper bound of 120,000 king salmon, however, this was largely due to long term closures of the subsistence fishery. Restrictions to the subsistence king salmon fishery are expected again in 2016.

The anticipated closure of the subsistence fishery on the Kuskokwim River warrants a total closure of sport fishing for king salmon in the Kuskokwim River drainage and the prohibition of bait and multiple hooks.
