### EXPLANATION:

This emergency order closes all waters of the Yukon River drainage (excluding the Tanana River drainage) to sport fishing for king salmon.

All king salmon caught unintentionally in the Yukon River drainage (excluding the Tanana River drainage) while fishing for other species may not be removed from the water and must be released immediately.

### REGULATION:

The provisions of 5 AAC 73.010. Seasons, bag, possession, and size limits, and methods and means for the Yukon River Area. (b)(1) are superseded by this emergency order. Under this emergency order, the following provisions are effective, 12:01 a.m. Friday, April 29 through 11:59 p.m. Saturday, December 31, 2016:

#### **5 AAC 73.010. Seasons, bag, possession, and size limits, and methods and means for the Yukon River Area.**

(b)(1) sport fishing for king salmon is closed; king salmon may not be taken or possessed. Any king salmon incidentally caught while fishing for other species may not be removed from the water and must be released immediately.

**JUSTIFICATION:**

King salmon stocks throughout western Alaska are continuing to experience a period of low productivity and, since at least 2010, below average run strength. The 2016 preseason outlook indicates that the Yukon River king salmon run in 2016 will be below average, with no or very little harvestable surplus available. In 4 of the past 8 years the interim management escapement goal for king salmon in Canada was not attained, and during 2009, 2011, 2014 and 2015, the interim goal was attained only due to increasingly conservative management, including closures or severe restrictions to subsistence opportunity, complete closure of directed commercial fishing and no sale of king salmon caught during chum salmon commercial fishing periods, and sport fishery closures. To conserve king salmon bound for Canada and to account for uncertainty in the preseason outlook, the Alaska Board of Fisheries modified the Yukon River King Salmon Management Plan in January 2013. With this modification (5 AAC 05.360 (j)), the department shall not open any subsistence fishing periods in Districts 1 and 2 during the first pulse of king salmon migration.

Under the 2016 preseason management strategy, the subsistence fishery for king salmon will close with the first arrival of king salmon in the coastal districts. This closure will be implemented chronologically in each district with the upriver migration of king salmon. No directed commercial fishery for king salmon or sale of king salmon caught incidentally in other commercial fisheries will be permitted. The use of selective fishing gear (dip nets, beach seines, and closely attended wheels) will be required during the commercial summer chum salmon fishery openings that occur when king salmon are present; king salmon caught incidentally during these periods must be released immediately to the water alive. The anticipated low abundance of king salmon into the Yukon River, the recent failures to meet Canadian border passage goals and escapement targets in Alaska, and restrictions placed on the subsistence fishery, warrant a closure to sport fishing for king salmon in the Yukon River drainage.
