#### **EXPLANATION:**

This emergency order increases the bag and possession limit for sockeye salmon, from five per day to ten per day, in all waters of the Alagnak River drainage. The limit for other salmon, except king, coho, and sockeye salmon, remains at five per day, five in possession. These limits are in combination with the more liberal limit for sockeye salmon.

#### **REGULATION:**

The provisions of 5 AAC 67.022. Special provisions for seasons, bag, possession, and size limits, and methods and means in the Bristol Bay Area. (f) (5) (C) are added by this emergency order. Under this emergency order, the following provisions are effective beginning 12:01 a.m. Thursday, July 19 through 11:59 p.m. Monday, December 31, 2018:

 $5AAC\ 67.022$ . Special provisions for seasons, bag, possession, and size limits, and methods and means in the Bristol Bay Area.

(f) (5) in the Alagnak River drainage,

(C) the bag and possession limit for sockeye salmon is ten fish; the bag and possession limit for other salmon, other than king and coho salmon, is five fish;

#### **JUSTIFICATION:**

The Alagnak River has a minimum sustainable escapement goal of 320,000 with no upper end. Through Tuesday, July 17, 2018, over 1 million sockeye salmon have been counted at the Alagnak River tower. As provided by 5 AAC 75.003 (2) (A), ADF&G has emergency order authority to increase sport fish bag and possession limits when the total escapement is projected to exceed the escapement goal and the total harvest under the increased bag and possession limit will not reduce the escapement below the goal range. Therefore, it is warranted to increase the bag and possession limit for sockeye salmon in the Alagnak River sport fishery.
