### **EXPLANATION:**

This emergency order supersedes Emergency Orders 2-KS-1-20-18, issued Monday, June 18, 2018, and 2-KS-1-25-18, issued Thursday, June 21, 2018. This emergency order prohibits the retention of king salmon while sport fishing in the Kenai River from its mouth upstream to an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek. Only one unbaited, single-hook, artificial lure may be used when sport fishing in these waters. King salmon may not be retained or possessed, may not be removed from the water, and must be released immediately.

The closure for sport fishing for king salmon in waters of the Kenai River drainage from an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek, upstream to an ADF&G marker located at the outlet of Skilak Lake, remains in effect through 11:59 p.m. Tuesday, July 31, 2018.

### **REGULATION:**

Consistent with the stipulations within 5 AAC 21.359. Kenai River Late-Run King Salmon Management Plan. (e)(1), the provisions of 5 AAC 57.120. General provisions for the seasons, bag, possession, annual, and size limits, and methods and means for the Kenai River Drainage Area. (a)(2)(A) and 5 AAC 57.121. Special provisions for the seasons, bag, possession, and size limits, and methods and means for the Lower Section of the Kenai River Drainage Area. (1)(A) and (B) are superseded by this emergency order. The following provisions are effective 12:01 a.m. Wednesday, July 18 through 11:59 p.m., Tuesday, July 31, 2018:

#### **5 AAC 57.120. General provisions for the seasons, bag, possession, annual, and size limits, and methods and means for the Kenai River Drainage Area.**

(a)(2) king salmon 20 inches or greater in length, as follows:

(A) July 18 – July 31, in the Kenai River from its mouth upstream to an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek, retention of king salmon is prohibited, king salmon may not be retained or possessed, may not be removed from the water and must be released immediately, as follows:

(i) from July 18 - July 31, from an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of the Slikok Creek upstream to an ADF&G regulatory marker located at the outlet of Skilak Lake, sport fishing for king salmon is prohibited;

#### **5 AAC 57.121. Special provisions for the seasons, bag, possession, and size limits, and methods and means for the Lower Section of the Kenai River Drainage Area.**

(1) sport fishing gear restrictions:

(A) from July 18 – July 31, in the Kenai River from its mouth upstream to an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek, only one unbaited, single-hook, artificial lure may be used;

(B) from July 18 – July 31, in the Kenai River from an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek, upstream to an ADF&G regulatory marker located at the outlet of Skilak Lake; only one unbaited, single-hook, artificial lure may be used;

**JUSTIFICATION:**

The purpose of 5 AAC 21.359 *Kenai River Late-Run King Salmon Management Plan* is to ensure adequate escapement of late-run king salmon into the Kenai River system and provide management guidelines to the department. The sustainable escapement goal (SEG) for late-run Kenai River king salmon is 13,500 to 27,000 king salmon 75 cm (29.53 inches) mid-eye to tail fork and longer.

In 2018, king salmon runs throughout Cook Inlet have consistently and significantly underperformed preseason expectations resulting in restrictions and closures of inriver and marine sport fisheries. As of July 14, 2018, approximately 2,770 king salmon 75 cm (29.53 inches) mid-eye to tail fork and longer have passed the river mile 13.7 king salmon sonar, the quarter point of the late run is historically around July 17. Without further restrictions to harvest, the SEG for Kenai River late-run king salmon is not expected to be achieved. Therefore, consistent with the management plan, it is warranted to prohibit retention of king salmon of all sizes in the sport fishery. As further specified in the management plan, if the use of bait and retention is prohibited in the sport fishery, the retention of king salmon is prohibited in the personal use fishery, and commercial fishing periods of the Upper Subdistrict, excluding the East forelands, will be open for no more than 24 hours a week with a 36-hour continuous closure per week beginning between 7:00 p.m. Thursday and 7:00 a.m. Friday.

**PREVIOUS EMERGENCY ORDERS AFFECTED:**

Emergency Order No. 2-KS-1-20-18, issued Monday, June 18, 2018, which closed waters of the Kenai River drainage from an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek, upstream to an ADF&G marker located at the outlet of Skilak Lake, is superseded by this emergency order

Emergency Order No. 2-KS-1-25-18, issued Thursday, June 21, 2018, which prohibited the use of bait while sport fishing in the Kenai River from its mouth upstream to an ADF&G regulatory marker located approximately 300 yards downstream from the mouth of Slikok Creek is superseded by this emergency order.
