EXPLANATION:

This emergency order closes the Kuskokwim River drainage (excluding Kuskokwim Bay drainages) to sport fishing for king salmon. In addition, only one unbaited, single-hook, artificial lure may be used in the Kuskokwim-Goodnews Area.

All king salmon caught incidentally in the Kuskokwim River drainage while fishing for other species may not be removed from the water and must be released immediately.

REGULATION:

The provisions of 5 AAC 71.010. Seasons and bag, possession, annual, and size limits for the Kuskokwim-Goodnews Area. (c)(3)(A) and (B) are superseded and (c)(1) and (d)(1)(G) are added by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Tuesday, May 1 through 11:59 p.m. Wednesday, July 25, 2018:

5 AAC 71.010. Seasons and bag, possession, annual, and size limits for the Kuskokwim-Goodnews Area.

(c)(3)(A) sport fishing for king salmon is closed; king salmon may not be taken or possessed.

(c)(3)(B) the bag and possession limit for pink, sockeye, chum, and coho salmon is three fish, with no size limit; however, the aggregate daily bag and possession limit of all salmon species may not exceed three salmon.

(c)(10) in the Kuskokwim River drainage, sport fishing for king salmon is closed; king salmon may not be taken or possessed.

(d)(1)(G) only one unbaited, single-hook, artificial lure may be used in the remainder of the Kuskokwim – Goodnews Area not specified in (d)(1)(A-F).

JUSTIFICATION:

Preseason projections suggest that the Kuskokwim River king salmon run in 2018 may be similar to 2017 when the Kuskokwim River experienced an estimated total run of approximately 166,000 and spawning escapement of approximately 150,000. In 2017, the drainagewide escapement goal exceeded the upper bound of 120,000 king salmon, however, this was largely due to long term closures of the subsistence fishery. Restrictions to the subsistence king salmon fishery are expected again in 2018.

The anticipated closure of the subsistence fishery on the Kuskokwim River warrants a total closure of sport fishing for king salmon in the Kuskokwim River drainage and the prohibition of bait and multiple hooks.
