EXPLANATION:

This emergency order increases the pink salmon bag and possession limit in the saltwaters of Port Valdez north of a line from Potato Point to Entrance Point (Valdez Narrows) to 12 per day, 24 in possession. Fresh water salmon closures remain in effect for Port Valdez.

REGULATION:

The provisions of 5 AAC 55.023. (1)(B)(ii) are superseded by this emergency order. Under this emergency order the following provisions are effective 12:01 a.m. Friday, Aug 2, 2019:

5 AAC 55.023. Special provisions for seasons, bag, possession, and size limits, and methods and means for the Prince William Sound Area.

- (1) the following special provisions apply to salmon, other than king salmon:
 - (B) within the following terminal harvest areas, the bag limit is six fish; and the possession limit is 12 fish:
 - (ii) Valdez vicinity: the salt waters north of a line from Point Freemantle to Rocky Point, excluding Jack Bay, Sawmill Bay, and Galena Bay; except that in all salt waters north of a line from Potato Point to Entrance Point, the bag limit for pink salmon is 12 fish; and the possession limit is 24 fish;

JUSTIFICATION:

As provided in 5 AAC 75.003 (2)(B), the department may use emergency order authority to increase sport fish bag and possession limits when hatchery-produced fish escape through existing fisheries to designated harvest areas in numbers that exceed brood stock needs or any natural spawning requirements. Pink salmon returns to the Valdez Fisheries Development Association (VFDA) Solomon Gulch Hatchery (SGH) are far above anticipated. Pink salmon cost recovery efforts for this hatchery have been completed and they have secured sufficient broodstock at SGH. No wild stock concerns will occur from the increased

bag and possession limits in the designated area and it is warranted to provide additional harvest opportunity in the Port Valdez marine waters for these surplus hatchery fish.
