### EXPLANATION:

This emergency order closes all waters of the Delta Clearwater River drainage, including the Delta Clearwater Lake drainage to sport fishing for coho salmon. Additionally, only unbaited, single-hook, artificial lures may be used.

### REGULATION:

The provisions of 5 AAC 74.010 (c)(5) and (d)(6) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Friday, October 11:

### **5 AAC 74.010. Seasons, bag, possession, and size limits, and methods and means for the Tanana River Area.**

(c)(5) in the Delta Clearwater River drainage, including the Clearwater Lake drainage;

(A) the bag and possession limit for Arctic grayling is one fish, 12 inches or less in length: all Arctic grayling caught that are greater than 12 inches in length must be released immediately;

(B) sport fishing for coho salmon is closed; coho salmon may not be taken or possessed.

(d)(6) in the Delta Clearwater River drainage, including the Clearwater Lake drainage, only one unbaited, single-hook, artificial lure may be used;

### JUSTIFICATION:

The Delta Clearwater River coho salmon sport fishery is managed using inseason escapement data. The fishery management objective is to achieve an escapement that falls within the sustainable escapement goal (SEG) range of 5,200 – 17,000 fish. Escapement is monitored from late September through November 1, when peak counts have historically occurred.

Based on preliminary survey counts in an 8-mile index area of the Delta Clearwater River, the coho salmon run is projected to not achieve the lower end of the SEG. The number of fish counted on September 24 was 215 coho salmon, 524 on September 30, and 926 on October 7. Several lower Yukon River test fisheries also have projected a below average coho salmon run. Due to these indicators of a poor coho salmon run, a closure of the coho salmon sport fishery is warranted.
