EXPLANATION:

This emergency order restricts gear to only one unbaited, single-hook, artificial lure in the Anchor River and Deep Creek from May 16 through June 30.

REGULATION:

The provisions of 5 AAC 56.122. (a)(2)(A) and (a)(5)(A) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Saturday, May 16 through 11:59 p.m. Tuesday, June 30, 2020:

5 AAC 56.122. Special provisions for the seasons, bag, possession, annual, and size limits, and methods and means for the Kenai Peninsula Area.

(a)(2) Anchor River drainage, except Bridge Creek Reservoir:

(A) in flowing waters, from May 16 - July 15 and from September 1 - October 31, only one unbaited, single-hook, artificial lure may be used;

(a)(5) Deep Creek drainage:

(A) in flowing waters, from May 23 - July 15 and from September 1 - October 31, only one unbaited, single-hook, artificial lure may be used;

JUSTIFICATION:

Anchor River and Deep Creek king salmon stocks have experienced variable run sizes over the last two years. The sustainable escapement goal (SEG) for Anchor River king salmon is 3,800 - 7,600 fish. The lower bound of the Deep Creek SEG is 350 king salmon based on an aerial survey. In 2018, the SEG was not achieved for Anchor River or Deep Creek king salmon despite closing the fisheries early in the season. In 2019, the SEG was met for both stocks with preseason emergency order restrictions. With the uncertainty of the 2020 run strength for these stocks, it is justified to begin the 2020 season conservatively.

Increased harvest opportunity may be allowed by subsequent emergency order, if inseason assessment indicates the runs are stronger than anticipated and are sufficiently strong enough to achieve goals.
