## *Emergency Order*

### **EXPLANATION:**

This emergency order prohibits king salmon fishing (including catch-and-release) while sport fishing within one mile of shore in the saltwaters of Cook Inlet north of the latitude of Bluff Point (59° 40.00' N. lat.). King salmon incidentally caught while fishing for other fish may not be removed from the water and must be released immediately.

### **REGULATION:**

The provisions of 5 AAC 58.055. (g) are added by this emergency order. Under this emergency order the following provisions are effective 12:01 a.m. Wednesday, June 3 through 11:59 p.m. Wednesday, July 15, 2020:

#### **5 AAC 58.055. Upper Cook Inlet Summer Salt Water King Salmon Management Plan.**

(g) Notwithstanding (d) of this section, from June 3 through July 15, in the Cook Inlet salt waters within one mile of shore north of the latitude of Bluff Point (59° 40.00' N. lat) sport fishing is allowed, sport fishing for king salmon is prohibited; king salmon may not be retained or possessed; king salmon that are caught while fishing for other species may not be removed from the water and must be released immediately.

### **JUSTIFICATION:**

The sustainable escapement goal (SEG) for Anchor River king salmon is 3,800-7,600 fish. As of May 31, 2020, only 184 king salmon have been counted using a combination of sonar and video weirs. Based on 2017-2019 average run timing, ADF&G is projecting the SEG will not be achieved and has closed sport fishing on the Anchor River and Deep Creek to reduce the mortality of king salmon in these drainages.

Based on genetic analysis from 2014-2018, approximately 10% to 25% of the early run harvest north of Bluff Point originated from Cook Inlet streams. In waters north of Bluff Point, maturing king salmon (spawners) tend to be harvested near shore at a greater rate than immature (nonlocal) king salmon. From 2014-2018, the king salmon harvest north of Bluff Point >1 mile from shore was primarily comprised of outside Cook Inlet stocks. Therefore, it is justified to prohibit sport fishing for king salmon in salt waters

within one mile of shore while these locally spawning king salmon, migrate through the area and into fresh water.

**PREVIOUS EMERGENCY ORDERS AFFECTED:**

Emergency Order 2-KS-7-05-20 issued February 26, 2020, reduced the annual limit of king salmon 20 inches or greater in length harvested in Cook Inlet salt waters north of the latitude of Bluff Point (59° 40.00' N. lat.) from five to two fish and remains in effect.
