EXPLANATION:

This emergency order opens the Chitina Subdistrict for a 96-hour period on June 10, 2021. This fishing period and tentative openings after this period are listed in the schedule below. Additional emergency orders will implement or change this schedule based on actual numbers of fish passing the Miles Lake Sonar. After August 31, the fishery will remain open, by regulation, through September 30.

Consistent with 5 AAC 77.001(b) and 5 AAC 77.591 *Copper River Personal Use Dip Net Salmon Fishery Management Plan*, the personal use dip net salmon fishery in the Chitina Subdistrict of the Upper Copper River District will be open from 12:01 a.m. Thursday, June 10 through 11:59 p.m. Sunday, June 13.

JUSTIFICATION:

The Copper River personal use fishery is managed under direction of the *Copper River Personal Use Dip Net Salmon Fishery Management Plan* (5 AAC 77.591). The plan establishes the season from June 7 through September 30 and directs the department to establish weekly periods based on Miles Lake sonar counts. During May 24 - 30, there were 43,746 salmon counted past the Miles Lake sonar. The preseason projection for this period was 87,059 salmon, which results in a deficit of 43,313 salmon. Copper River sockeye salmon migratory timing and the previous five-year average harvest and participation rates indicate sufficient numbers of salmon available to allow 96 hours of fishing time during the week of June 7 - 13, a reduction of 72 hours from the preseason schedule.
