## *Emergency Order*

### EXPLANATION:

This emergency order extends the youth-only sport fishery in the Seward Lagoon and waters draining out of the Seward Lagoon (lagoon outfall streams) by 16 days. This extension will provide additional sport fishing opportunity for individuals that are under the age of 16 years old to fish for king salmon until 11:59 p.m. Sunday, July 16, 2023.

### REGULATION:

The provisions of 5 AAC 56.122 (a)(9)(C)(i) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Saturday, July 1 through 11:59 p.m. Sunday, July 16, 2023:

#### **5 AAC 56.122. Special provisions for the seasons, bag, possession, annual, and size limits, and methods and means for the Kenai Peninsula Area.**

(9) Resurrection Bay drainages:

(C) Seward Lagoon and the waters draining out of Seward Lagoon are closed to sport fishing, except that a person under 16 years of age may sport fish during a designated youth sport fishery, as follows:

(i) unless modified by emergency order, the designated youth sport fishery occurs for king salmon from July 1 – July 16;

### JUSTIFICATION:

The Seward Lagoon and waters draining out of the lagoon are stocked annually by the department with king salmon smolt to provide sport fishing opportunity. King salmon returning to this location are primarily caught in salt water, but the Alaska Board of Fisheries established a youth-only fishery to provide sport fishing opportunity for youth anglers in the lagoon and waters flowing from the lagoon. The fish returning to these waters are not intended to naturally reproduce in the lagoon or be used for hatchery broodstock. With late run-timing throughout the region, fish are still returning to the lagoon at this time

and extending the season of the youth-only sport fishery is warranted to provide additional angling opportunity to youth anglers under the age of 16 years old to harvest remaining king salmon.
