EXPLANATION:

This emergency order closes the sport fishery for shrimp in two portions of District 13.

REGULATION:

Under this emergency order the provisions of 5 AAC 47.021(g)(9) and 5 AAC 47.021(g)(10) are added. The following provisions are effective from 12:01 a.m. Thursday, January 1 through 11:59 p.m. Thursday, December 31, 2026:

5 AAC 47.021. Special provisions for seasons, bag, possession, annual, and size limits, and methods and means for the salt waters of the Southeast Alaska Area.

(g)(9) in a portion of Hoonah Sound, north and west of a line from 57° 35.07' N. lat., 135° 33.57' W. long., to 57° 37.89' N. lat., 135° 28.65' W. long., sport fishing for shrimp is closed;

(g)(10) in a portion of Crawfish and West Crawfish Inlet north and east of a line from 56°46.77' N. lat., 135°16.83' W. long. to 56°41.14' N. lat., 135°13.75' W. long., sport fishing for shrimp is closed.

JUSTIFICATION:

Catch per unit effort data from both the commercial and subsistence fisheries in Crawfish Inlet and West Crawfish Inlet indicate declining spot shrimp stock health. The intention of this closure is to allow spot shrimp abundance to rebuild to levels that would allow sustainable harvest.

The Section 13-C spot shrimp survey has been conducted annually by the Alaska Department of Fish and Game from 1999 through 2014 and from 2017 through 2025. From 1999 to 2014 the spot shrimp population in Hoonah Sound was considered healthy and relatively stable based on survey data and commercial fishing harvests. Beginning in 2015, commercial spot shrimp harvest data indicated declining stock health. Spot shrimp surveys conducted in Hoonah Sound from 2017 to 2022 showed a decline in catch rates (lb/pot) of younger, small spot shrimp. Surveys conducted in 2023 and 2024 showed a small increase in catch rates of small spot shrimp; however, results of the 2025 survey showed a decrease in catch rates of both small and large spot shrimp.

The sport shrimp fishery has been closed in Hoonah Sound since March of 2020. The subsistence fishery was closed 2020-2024 but reopened in 2025 with significant gear restrictions. Additionally, the commercial pot shrimp fishery in Section 13-C will continue to be closed through the 2026/27 season. The closures of these shrimp fisheries are warranted to protect the younger age classes and the older female spot shrimp to aid in the recovery of the stock.
