

- 1. Election of Officials: Karl Johnstone was voted as Chair by unanimous consent. Tom Kluberton was voted as Vice-Chair by unanimous consent.
- 2. 2014/2015 Committee Assignments: The Board Chair made 2014/2015 subcommittee assignments. Assignments include

 - e. Joint BOF/NPFMC Protocol, Jensen/Chair, Jeffrey, Kluberton, Johnstone (Alt.)
 - f. Legislation, Morisky/Chair, Johnstone, Huntington
 - g. Possession Limits Task Force, Johnstone/Chair, Jeffrey, Morisky
 - h. Sustainable Salmon Fisheries Policy Task Force, Kluberton/Chair, Jeffrey, Jensen
- 3. 2016/2017 Meeting Locations and Dates: The board established the following locations and dates for its 2016/2017 meetings.

- 5. Federal Waters: The Board heard a report from ADF&G's Office of Extended Jurisdiction and an update from Ed Dersham, Council member with the North Pacific Fishery Management Council.
- 6. ACR Meeting Time: The board determined that all accepted ACRs would be deliberated on at the Statewide Dungeness, Shrimp, Miscellaneous Shellfish and Supplemental Issues meeting in Anchorage, March 17 20, 2015.
- 7. Seine Vessel Length Working Group established: Regarding the subject of ACR 26 and Proposal 202 from the 2014/2015 meeting cycle, Mr. Kluberton recommended convening a working group of relevant agencies and interested stakeholders to discuss the subject of measuring seine vessel

length. This working group is tentatively planned for the Sitka Southeast and Yakutat Finfish meeting, February 23-March 3, 2015.

- 8. Changes to the ACR form: The Board amended its agenda change request form to add language encouraging submitters to directly answer all questions in the form, and to add a specific deadline date (to be changed annually according to the regulation that ACRs are to be submitted 60 days before the board's work session).
- 9. Call for Proposal review process: The board reviewed its call for proposal review process and determined to clarify in the call for proposal that proposals that do not meet the call will not be published in the proposal book. Proposals that do not meet the call include those for the regions/species not in cycle, and not submitted timely. The board also approved not including those proposals from the same proposer if they are clearly duplicates.
- 10. Kuskokwim Work Group established: In its review of ACR #8, the board discussed and later set in place under miscellaneous business, the creation of a Kuskokwim Work Group. The named work group members are Mr. Kluberton (chair), Mr. Huntington, and Mr. Johnson. The group will work with the department on outreach and information gathering with residents in the Kuskokwim prior to deliberating on the accepted ACRs at the Statewide Meeting. Beyond actions taken at the March Statewide meeting, the work group will continue to look at other options and opportunities and provide additional information to the board at its 2015 work session.
- 11. Gulf of Alaska Pollock Work Group report: Members Ms. Jeffrey and Mr. Jensen, co-chairs of the Gulf of Alaska Pollock Working Group, provided a report to the board regarding the efforts of the work group and indicated plans for an additional meeting prior to board deliberations on Proposal 44 at the Statewide Meeting in March 2015.
