NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE ALASKA BOARD OF GAME

The Alaska Board of Game proposes to adopt regulation changes in Title 5 of the Alaska Administrative Code, dealing with the use and taking of game. Regulations subject to board action are in 5 AAC 84, 85, 92, and 99. The subject matter areas to be addressed concern Game Management Units 1, 5, 6, 7, 9, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, and 26, including, but not limited to the following:

- A. TRAPPING SEASONS AND BAG LIMITS in Units 12, 14, 19, 20, 21, 24, 25, 26B and 26C, including but not limited to: beaver, lynx, black bear, brown bear, and wolverine.
- B. HUNTING SEASONS AND BAG LIMITS in Units 12, 19, 20 21, 24, 25, 26B and 26C including, but not limited to: beaver, lynx, black bear, brown bear, moose, caribou, Dall sheep, wolves, and wolverine; black bear in Unit 16B; caribou and moose in Unit 18 including the amount necessary for subsistence; Dall sheep in Units 13 and 14; musk ox in Units 22 and 23; and reauthorization of antlerless moose hunts statewide.
- C. LICENSES, HARVEST TICKETS, HARVEST REPORTS, TAGS, FEES, AND PERMITS in Units 12, 19, 20, 21, 24, 25, 26(B) and 26(C), including, but not limited to: discretionary and required permit hunt conditions and procedures; antler destruction requirements; special provisions for moose and Dall sheep drawing permit hunts; Tier II subsistence hunting permit point system; and reauthorization of brown bear tag fee exemptions in all Units statewide
- D. HUNTING AND TRAPPING METHODS AND MEANS in Units 12, 19, 20, 21, 24, 25, 26(B) and 26(C) including, but not limited to: methods of taking beaver while trapping; lawful methods of taking game, big game, and furbearers, including trapping black and brown bear and taking black bear brown bear using bait and scent lures; restricting hunting with the use of boats and land vehicles; taking wolf and bear from dens;
- E. POSSESSION, TRANSPORTATION, AND USE OF GAME in Units 12, 19, 20, 21, 24, 25, 26(B) and 26(C) including, but not limited to sealing of bear skins and skulls; salvage of game meat, furs, and hides; taking cub bears and female bears with cubs;
- F. RESTRICTED AREAS AND GAME MANAGEMENT UNITS in Units 12, 19, 20, 21, 24, 25, 26(B) and 26(C) including, but not limited to: Areas closed to hunting, areas closed to trapping, closures and restrictions in state game refuges, management areas, and controlled use areas; and a wildlife refuge in Unit 13.
- G. GENERAL PROVISIONS AND DEFINITIONS including, but not limited to: classifying black and brown bear as a furbearer, and hunter education and orientation requirements.
- H. INTENSIVE MANAGEMENT: Population and harvest objectives, control of predation by wolves and bears, and predation control implementation plans including Units 9, 12, 13, 17, 16, 19, 20, and 25.

You may comment on the regulation changes, including the potential costs to private persons of complying with the changes, by submitting written comments to the Alaska Board of Game, Board Support Section, at P.O. Box 115526, Juneau, AK 99811-5526. Comments may also be submitted by fax to (907) 465-6094. Comments will be accepted at any time prior to the time the board considers the action regarding the regulation changes, but to ensure distribution to board members, comments should be submitted to the above address or fax number by 5:00 p.m. February 15, 2008. Written comments that are submitted are public record and are subject to public inspection.

The public hearing portion of the meeting will begin immediately after staff reports. The public hearing will continue until everyone has been given the opportunity to be heard. Additional public hearings may be held throughout the meeting just before consideration and adoption of proposed changes in the regulations. An agenda will be posted during the meeting. The board will take oral testimony from those who register before the cut-off time announced by the board chairman. The length of oral statements may be limited to three to five minutes, or less.

Pursuant to AS 44.62.200, the board may review the full range of activities appropriate to any of the subjects listed in this notice. The board may make changes to the hunting and trapping regulations as may be required to ensure the subsistence priority in AS 16.05.258.

After the public hearing, the Board of Game may adopt these or other provisions dealing with the same subject, without further notice, or amend, reject, supplement, or decide to take no action on them. The language of the final regulations may be different from that of the proposed regulations. You should comment during the time allowed if your interest could be affected.
