Community Harvest

- NA 23 Repeal the community harvest hunt.
CA 20 Reestablish community harvest hunt. (*Amended to revise the community harvest hunt permit conditions; establish a Tier I hunt and a drawing hunt, both with permit conditions; and eliminate antler destruction requirements.*)
NA 26 Modify the community harvest permit to require applicants to first qualify for a Tier II permit.

Tier I Permit Conditions

- NA 29 Review Tier I permit conditions.
NA 22 Repeal the Tier I permit condition that prohibits hunting moose in other areas.
NA 24 Issue Tier I permits on a rotational basis.
NA 3 Modify Tier I caribou to allow one caribou every 2 years and 2 per household.

Unit 13 Predation Control Area

- CA 31 Reauthorize the Unit 13 predation control area. (*Amended with technical changes.*)

Unit 26B Brown Bear

- CA 32 Modify brown bear season in portion of Unit 26B.

Black Bear Trapping

- D 36 Adopt regulations establishing black bear trapping in Units 12, 16B, 19A, 19D, 20E, and 25D. (*Deferred to the Spring, 2012 meeting; amended to apply to Units 12, 19E, and 25B.*)
NA 33 Reclassify black bear as a furbearer in Units 12, 20 and 25, and allow sale of hides.
C 34 Allow the harvest of any black bear in Unit 25D.
NA 35 Allow black bear snaring in Unit 25D.
