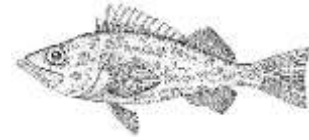

2019 FALL DEMERSAL SHELF ROCKFISH FISHERY ANNOUNCEMENT

Sitka. . . The Alaska Department of Fish and Game (ADF&G) announced today the 2019 fall directed commercial fishery for Demersal Shelf Rockfish (DSR) will open in portions of the Northern Southeast Inside (NSEI) and Southern Southeast Inside (SSEI) Subdistricts on Friday, November 15, 2019, at 9:00 a.m. These areas will remain open until allocations are taken or until 4:00 p.m., December 31, whichever occurs first. Catch and effort will be closely monitored and area closures may occur on short notice. Closures will be announced by ADF&G news release, United States Coast Guard "Notice to Mariners" report, and National Weather Service broadcast. Area closures will also be announced on the Groundfish Hotline at (907) 747-4882.

The DSR assemblage includes yelloweye, quillback, canary, copper, China, tiger, and rosethorn rockfish.

Harvest Guidelines for the Directed DSR Fishery

The following waters are closed to directed fishing for DSR:

In the Ketchikan vicinity: all waters of Behm Canal, Clarence Strait, Tongass Narrows, Nichols Passage, George Inlet, Carroll Inlet, Thorne Arm, Revillagigedo Channel, and all contiguous waters enclosed by the latitude of Bushy Point Light, a line from Point Alava to the southernmost tip of Ham Island, a line from Cedar Point to Dall Head, and a line from Dall Head to a point in midstream Clarence Strait at the latitude of Dall Head to Caamano Point.

In the vicinity of Craig and Klawock: all waters of Ulloa Channel north of the latitude of Waterfall Cannery and all waters enclosed by a line from the southernmost tip of St. Philip Island to the northernmost tip of San Fernando Island to Point Cangrejo.

In NSEI: the waters of Glacier Bay north of a line from Point Carolus at 58°22.694' N. lat., 136°02.535' W. long., to Point Gustavus at 58°22.748' N. lat., 135°54.927' W. long., and the waters of Dundas Bay north and west of a line running from 58°22.900' N. lat., 136°25.300' W. long., and 58°23.600' N. lat., 136°24.600' W. long.

Annette Islands Reserve

Fishermen are reminded the Annette Islands Reserve is a federally recognized Indian reservation in Alaska. The waters within 3,000 feet of Annette Island, Ham Island, Hemlock Island, Spire Island, Walker Island,

Lewis Island, and adjacent rocks and islets are designated within the fishing reserve. Fisheries within the reserve are managed by the Metlakatla Indian Community for authorized fisheries participants.

Metlakatla residents are also reminded that waters beyond 3,000 feet of Annette Island, Ham Island, Hemlock Island, Spire Island, Walker Island, Lewis Island, and adjacent rocks and islets are managed by the State of Alaska. Proper licensing, permitting, and reporting are required.

General Provisions

Fishermen are required to register their vessel with ADF&G prior to participating in the fall directed DSR fishery. Logbooks are required and a copy of the logbook pages detailing a landing must be attached to the fish ticket at the time of that landing. Fishermen are required to report on logbooks the latitude and longitude for start and end positions of each set, amount of gear (skates and hooks), depth of each set, and amount of catch per set by species. Logbooks are available at ADF&G area offices.

In the Southeast District, DSR may be taken in the directed fishery by longline, hand troll, dinglebar troll, and mechanical jigging machines. A Commercial Fisheries Entry Commission (CFEC) "Y" interim use permit is required for the directed fishery. In the NSEI and SSEI Subdistricts, a vessel or CFEC permit holder may not take or possess on board the vessel or deliver more than 6,000 pounds of DSR in any five-day period. All DSR taken in excess of 6,000 pounds by a vessel or CFEC permit holder in any five-day period must be weighed and reported on an ADF&G fish ticket as a trip limit overage with proceeds surrendered to the State.

When fishing in the NSEI and SSEI Subdistricts, full retention of all rockfish is required (excluding thornyhead). If excess rockfish bycatch is sold, proceeds from the sale shall be surrendered to the State. The permit holder may retain excess rockfish bycatch (not DSR) for personal use in accordance with 5 AAC 39.010; the pounds must be documented as bycatch overage on the fish ticket.

Bycatch Provisions

Bycatch provisions for DSR longline and jig (mechanical jigging machines, dinglebar, and hand troll gear) permits are listed in the following table. Bycatch allowances (amount retained or sold) are based on the aggregate round weight of DSR onboard.

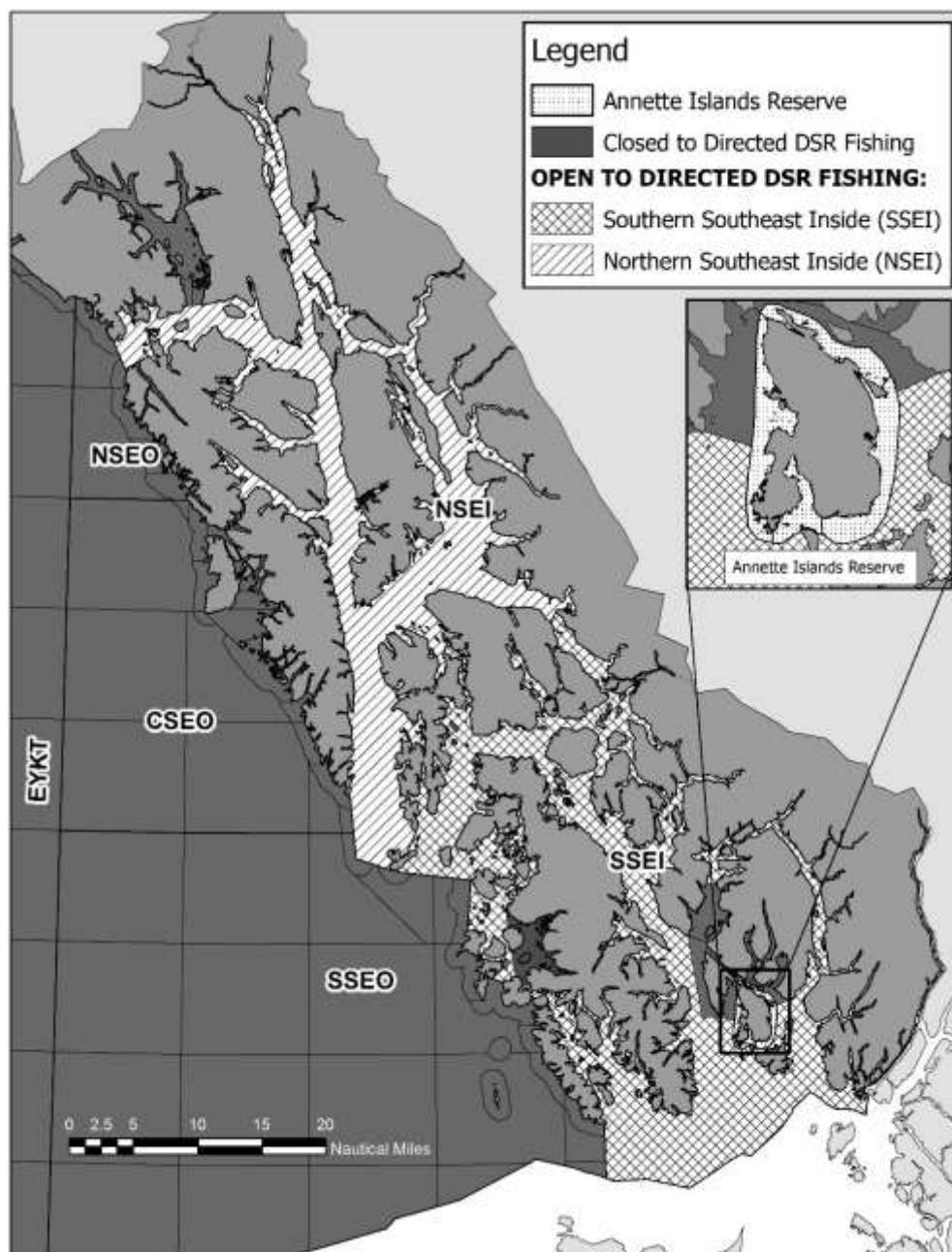
Bycatch Species	Bycatch Allowance
Lingcod	Longline fishery- 35% in SSEOC*; 0% in NSEI and SSEIW. Jig fishery- 20% in SSEOC. Jig bycatch closes November 30.* Jig fishery- 0% in NSEI and SSEIW.
Shortraker and Rougheye	7% in aggregate. Full retention required.
Black, Blue, and Dark Rockfish	15% in aggregate. Full retention required.
Thornyhead and Other Rockfish	15% in aggregate. Full retention required, excluding thornyhead.
Pacific cod	20%. Full retention required when directed Pacific cod season open.
Dogfish	Longline fishery- 35%. Jig fishery- 20%.
Sablefish	0%.
Other Groundfish	20%.

*Note: Lingcod bycatch is open in DSR fisheries utilizing longline, mechanical jigging machines, and hand troll gear in the portion of SSEI that overlaps with the Southern Southeast Outer Coast (SSEOC) Sector lingcod management area only. SSEOC includes those waters of SSEI that are south of the latitude of 56°00.000' N. lat., and west of Prince of Wales Island or south of 54°43.000' N. lat., and west of 132°00.000' W. long. Lingcod bycatch will be open to DSR longline and jig permit holders fishing in groundfish statistical areas 345535, 335533, 335534, 325501, 325502, 325433, 325431, 325401, and portions of 335535 and 335506.

The waters of the NSEI Subdistrict and Southern Southeast Internal Waters (SSEIW) Sector are closed to lingcod bycatch during the 2019 fall DSR fishery. The SSEIW area is defined as the waters of SSEI not included in SSEOC.

The minimum size limit for lingcod is 27" from tip of snout to tip of tail or 20.5" from front of dorsal fin to tip of tail. Lingcod allocations are managed by area and area closures will occur as allocations are taken.
