YAKUTAT COMMERCIAL SET GILLNET OPENING ANNOUNCEMENT

Alsek River: will be open from **12:01 p.m., Sunday, August 16, through 12:00 noon, Wednesday, August 19, 2020.**

East Alsek River: will be open from **12:01 p.m., Sunday, August 16, through 12:00 noon, Wednesday, August 19, 2020.**

Yakutat Bay: will be open from **12:01 p.m., Sunday August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Dangerous River: will be open from **12:01 p.m., Sunday August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Akwe River: will be open from **12:01 p.m., Sunday August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Lost River: will remain closed until further notice.

Situk-Ahrnklin Inlet: will be open from **12:01 p.m., Sunday, August 16, through 12:00 p.m., Wednesday, August 19, 2020,** with the following restrictions:

Lost River: will be closed to commercial set gillnet fishing north of a line from an ADF&G regulation marker located at 59°27.38' N lat, 139°36.55' W long (approximately 500 yards southeast from the Lost River-Situk Inlet confluence) to a regulation marker at 59°27.82' N lat, 139°37.46' W long (approximately 600 yards northwest from the Lost River-Situk Inlet confluence);

Situk River mouth (including upstream Johnson Slough marker): will be closed to commercial set gillnet fishing west of a line from an ADF&G regulation marker located at the eastern bank of Johnson Slough at 59°26.73' N lat, 139°33.25' W long to a buoy regulation marker located at 59°26.33' N lat, 139°34.15' W long, to a regulation marker located at 59°25.66' N lat, 139°34.43' W long on Sunny Point.

Chinook salmon retention: the Situk River commercial fishery is closed to the selling of Chinook salmon, but Chinook salmon can be retained for personal use. Please inform buyer that you are retaining Chinook salmon for personal use.

Manby Shore-Outside Waters: will be open from **12:01 p.m., Sunday, August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Manby Shore-Inside Waters: will be open from **12:01 p.m., Sunday, August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Remainder of the Yakutat District: will be open from **12:01 p.m., Sunday, August 16, through 12:00 p.m., Wednesday, August 19, 2020.**

Yakataga District, including the Kaliakh River: will open from **9:00 a.m., Sunday, August 16, through 9:00 a.m., Wednesday, August 19, 2020.**

Tsiu River: will remain closed until further notice.

Seal River: will remain closed until further notice.

The Emergency Order corresponding to this announcement is EO 1Y1320.
