SITKA SOUND HERRING FISHERY UPDATE # 24

Today's aerial survey was canceled due to poor weather. Through April 7, the cumulative estimate of observed herring spawn in Sitka Sound is approximately 33.3 nautical miles.

The Sitka Sound herring sac roe fishery will continue to be open from 8:00 a.m. until 6:00 p.m. daily until closed by field or advisory announcement in the waters of Deep Inlet and Aleutkina Bay south of 57°00.81' N lat and east of 135°21.93' W long, and the waters south of the latitude of Povorotni Point at 56°57.13' N lat and north of the latitude of Aspid Cape at 56°41.75' N lat, except for the waters of Whale and Necker Bays. Fishing boundaries and times may be modified by subsequent announcement.

Harvest from April 7 is confidential due to low participation. The estimated cumulative harvest through April 6 is approximately 15,700-tons of herring.

The next aerial survey is scheduled for Friday, April 9, and the next fishery update will be released after the aerial survey is completed.

Under Alaska's Health Advisories 1, 2, 3, and 4, commercial fishing is an Essential Business and is part of Alaska's Essential Services and Critical Infrastructure. Commercial fishermen should ensure that all travel and other activities in support of commercial fishing operations follow protocols in Alaska COVID-19 Health Advisories. 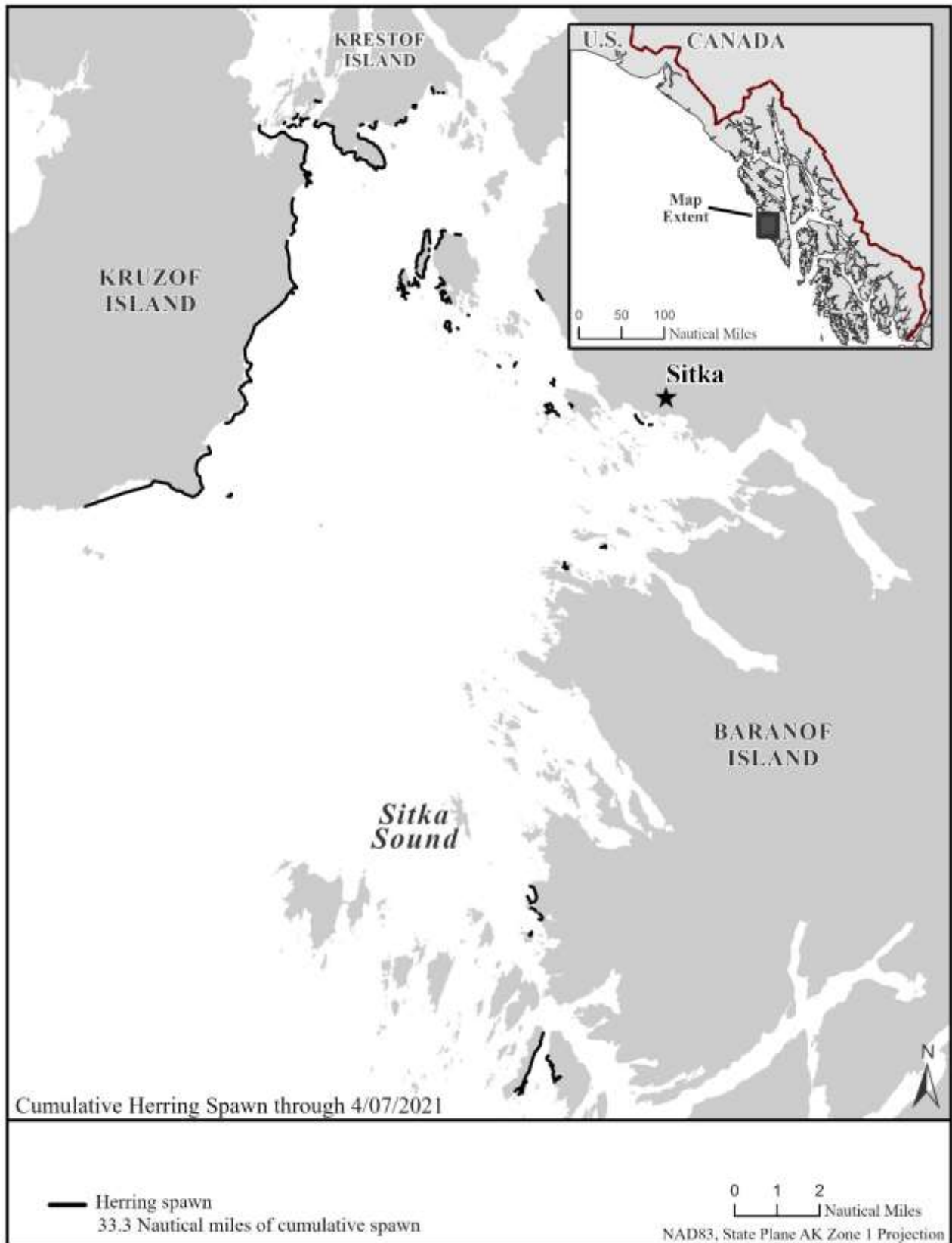


Figure 1.— Map of herring cumulative herring spawn observed in Sitka Sound through April 7, 2021
