Sand Point Commercial Salmon Fishery Advisory Announcement #19 For Emergency Order #4-FS-M-SP-17-21

Commercial salmon fishing by **set gillnet and seine gear** will be allowed in the Beaver Bay, Balboa Bay, Southwest Stepovak, East Stepovak, and Northwest Stepovak Sections of the Southeastern District for 131 hours from 9:00 a.m. Friday, August 27 until 8:00 p.m. Wednesday, September 1. The Stepovak Flats Section will remain closed.

Commercial salmon fishing by **set gillnet and seine gear** will be allowed in the inside waters of the Volcano Bay Section of the Southwestern District, north and west of a line from Arch Point at 55° 12.30' N. lat., 161° 54.30' W. long. to a point on Belkofski Peninsula at 55° 09.50' N. Lat, 161° 57.80' W. long. (Statistical Area 284-36) and in the waters of Zachary Bay of the Southeastern District, south of the latitude of 55° 22.60' N. lat. (Statistical Area 282-35) beginning at 9:00 a.m. on Friday, August 27 **until further notice**.

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
