## GROUNDFISH BYCATCH IN THE 2023 SALMON TROLL FISHERY

Commercial salmon troll permit holders operating hand or power troll gear in the Eastern Gulf of Alaska during an open commercial salmon fishing period may legally retain, possess, and sell incidentally taken groundfish in unlimited amounts, except where it is necessary to manage groundfish bycatch harvest within total catch limits (5 AAC 28.133).

## **Bycatch Provisions for the Salmon Troll Fishery in State Waters**

Bycatch allowances in state waters (internal waters and 0-3 nm) are summarized in the following table. State bycatch allowances that apply in adjacent federal waters (3-200 nm) are noted. The bycatch allowance for each species or species group reflects the percentage that may be retained and sold and is based on the round weight of salmon on board.




Figure 1.—Southeast Alaska Lingcod Management Areas. This map is for general reference only. For detailed descriptions of Lingcod Management Area boundaries, refer to 5 AAC 28.105.

<sup>1</sup>Lingcod Management Areas: Icy Bay Subdistrict (IBS), East Yakutat (EYKT) Section, Northern Southeast Outside (NSEO) Section, Central Southeast Outside (CSEO) Section, Southern Southeast Outer Coast (SSEOC) Sector, Northern Southeast Inside (NSEI) Subdistrict, Southern Southeast Internal Waters (SSEIW) Sector (Figure 1). Refer to **Lingcod Regulations** section of this announcement for additional restrictions on lingcod.

Lingcod and black, blue, and dark rockfish are state-managed species and the bycatch allowances for these species in federal waters (exclusive economic zone (EEZ)) are the same as those set for state waters. The DSR bycatch allowance is 10% in all state waters of the Southeast District and in those waters of the EEZ that are east of 140° W long. The bycatch allowance for other rockfish in the EEZ is 5% in aggregate. In IBS federal waters, DSR are aggregated with other rockfish and limited to 5% bycatch. Vessels trolling for salmon in the EEZ in the Gulf of Alaska that retain groundfish bycatch must have a Federal Fisheries Permit (FFP) endorsed for troll gear. If the vessel catches and retains any groundfish in the EEZ, the vessel is fishing for groundfish and must possess an FFP. For information on FFPs contact NOAA Fisheries at 907-586-7202 or 800-304-4846. An FFP is not required for vessels retaining groundfish bycatch in state waters or for lingcod or black, blue, or dark rockfish taken in the EEZ, as these species are exempt from federal permit requirements.

The DSR assemblage includes yelloweye, canary, quillback, copper, tiger, China, and rosethorn rockfish. DSR bycatch in excess of allowable limits shall be reported on an ADF&G fish ticket as bycatch overage. Proceeds from the sale of excess DSR bycatch taken in state waters shall be surrendered to the State of Alaska. All lingcod bycatch overage shall be surrendered to the State of Alaska.

## **Lingcod Regulations**

The retention of lingcod bycatch in the commercial salmon troll fishery is **open May 16–November 30, or until area-specific lingcod troll allocations are harvested.** All lingcod retained must measure at least 27" from tip of snout to tip of the tail or 20.5" from front of dorsal fin to tip of the tail. Lingcod management areas will be closed to lingcod retention as area troll allocations are taken. Vessels with lingcod bycatch on board may not fish in an area closed to troll lingcod retention until those lingcod have been offloaded from the vessel. Fishermen are advised that area closures may occur on short notice. Closures will be announced by ADF&G advisory announcement, United States Coast Guard "Notice to Mariners" report, the National Weather Service broadcast, and on the Groundfish Hotline 907-747-4882.

#### Lingcod in Sitka Sound

During the open lingcod season, a vessel fishing for salmon with troll gear in the waters of Sitka Sound, as described in 5 AAC 28.150(a), may retain and possess on board no more than two lingcod. The dorsal fin of each lingcod taken in this area must be removed immediately and the head must remain attached as evidence of compliance with the minimum size requirement. Having taken no more than two lingcod outside the Sitka Sound area, a vessel may fish for salmon within Sitka Sound only after removing the dorsal fin of those lingcod. Vessels in possession of more than two lingcod may not fish for salmon within this area until those lingcod are offloaded. Lingcod that have been marked by the removal of the dorsal fin may be utilized for personal use only and may not be sold. Personal use lingcod must be weighed and reported on the ADF&G troll salmon fish ticket and include the proper groundfish statistical area code, delivery code, and the personal use disposition code "95".

Regulation 5 AAC 28.150(a) describes Sitka Sound as those waters that are enclosed on the north by lines from Kruzof Island at 57°20.50′ N lat, 135°45.17′ W long, to Chichagof Island at 57°22.05′ N lat, 135°43′ W long, and from Chichagof Island at 57°22.58′ N lat, 135°41.30′ W long, to Baranof Island at 57°22.28′ N lat, 135°40.95′ W long, and on the south and west by a line running from the southernmost tip of Sitka Point at 56°59.38′ N lat, 135°49.57′ W long, to Hanus Point at 56°51.92′ N lat, 135°30.50′ W long, to the green day marker in Dorothy Narrows at 56°49.28′ N lat, 135°22.75′ W long, to Baranof Island at 56°49.28′ N lat, 135°22.60′ W long.

### **Closed Waters**

Groundfish may not be taken in the waters off Cape Edgecumbe (Edgecumbe Pinnacles Marine Reserve) enclosed by a box defined as 56°55.50′ N lat, 56°57.00′ N lat, 135°54.00′ W long, and 135°57.00′ W long.
