## SOUTHEAST ALASKA SALMON PROPOSED REGULATIONS NOTICE

Through advances in global positioning systems technology and availability, department staff and fishers identified differences between the markers in the field, some that have been there since statehood and even prior to statehood, that do not align with the locations listed in regulation. In response, Region 1 commercial fisheries area management staff underwent an extensive review of closed waters regulatory language in 5 AAC 29.150 and 33.350 to:

- correct errant latitudes and longitudes in regulation,
- assign accurate latitudes and longitudes to every point listed in regulation,
- delete obsolete regulations (e.g., closed waters contained within closed waters), and
- provide clearer descriptions of closed waters.

District and sections descriptions in 5 AAC 33.200 were updated in 2019 for similar reasons in a department regulations project and in the same manner as described above. The department recently identified three errant latitude and longitudes to correct and added additional language in two district descriptions to reduce ambiguity.

These updates will reduce confusion and ambiguity in regulation for ADF&G, AWT, and the commercial fishing sector and are not considered substantial or differ from what has been used in practice for many years if not since statehood, are not allocative, and follow the original intent of the regulation.

The commissioner of the Department of Fish and Game, under a delegation of authority issued by the Alaska Board of Fisheries under AS 16.05.270, is currently proposing to adopt changes in these regulations to correct these errors and omissions, ambiguities, and technical deficiencies.
