2023/24 SOUTHEAST ALASKA COMMERCIAL SHRIMP POT FISHERY CLOSURE

The following areas will close by regulation at 4:00 p.m., Wednesday, February 28, 2024:

Sections 3-B/C: Estimated harvest is 9,200 pounds with a guideline harvest level (GHL) of 20,000 pounds.

District 4: Estimated harvest is 13,200 pounds with a GHL of 20,000 pounds.

District 5: Estimated harvest is 4,800 pounds with a GHL of 12,000 pounds.

District 14: Estimated harvest is 6,100 pounds with a GHL of 7,500 pounds.

All shrimp pot gear must be removed from the water or placed in storage by the time of the closure. Pots may be stored in the waters of Sections 3-B/C and Districts 4, 5, and 14 until 4:00 p.m., Wednesday, March 6, 2024. Stored pots must have all doors secured fully open and all bait and bait containers removed.

Shrimp tickets must be submitted to an ADF&G office within seven days of the closure. Fishermen are reminded that catcher–sellers intending to sell shrimp to persons unlicensed to process shrimp (i.e. dock sales) must fill out an ADF&G fish ticket indicating the weight of the shrimp on board, by species, before any shrimp are removed from the vessel (5 AAC 31.143.[d]).

Catcher–processor vessels fishing in these areas are required to contact the ADF&G and report within 72 hours of the closure. Catcher–processor vessels must report the pounds in whole weight by species of shrimp on board the vessel taken during the open shrimp-fishing period.

Open areas and associated GHLs for the 2024/25 season will be announced in April.
