KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #14 For Emergency Order #4-FS-K-14-24

There will be a <u>57-hour</u> commercial salmon fishing period from **noon Sunday**, **July 28** to **9:00 p.m. Tuesday**, **July 30** in the following areas:

- The **Humpy-Deadman Section** of the **Alitak District**;
- The **Central** and **North Cape Sections** of the **Northwest Kodiak District** (all inner bays of the Northwest Kodiak District will remain closed);
- The Northeast Kodiak District:
- The Eastside Kodiak District;
- The Duck Bay, Southeast Afognak, Raspberry Strait, Southwest Afognak, Northwest Afognak, Shuyak Island, Pauls Bay, Perenosa Bay, and Northeast Afognak Sections of the Afognak District: and
- The **Mainland District**.

Closed Water Adjustments:

Closed waters in **Saltery Cove** will be the normal closed waters as described in regulation.

As previously announced:

The following areas remain open until further notice:

- The Izhut Bay, Outer Kitoi Bay, and Inner Kitoi Bay Sections of the Afognak District; and
- The **Spiridon Bay Special Harvest Area** (Telrod Cove).

Closed Water Adjustment:

Closed waters are **reduced** <u>until further notice</u> in the **Inner Kitoi Bay Section** to the ADF&G markers located in Little Kitoi and Big Kitoi bays (near stream #s 252-323 and 252-324).

<u>Until further notice</u>, in the Kodiak Area (including the Mainland District) Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the commercial fishery and must be returned to the water unharmed.

Concerning the North Shelikof Strait Fishery:

Short notice, inperiod closures may occur for seine fisheries in the Seaward Zones of the North Shelikof Strait area (**including the Cape Igvak Section**), as designated in the North Shelikof Strait Sockeye Salmon Management Plan (5 AAC 18.363). Closure announcements may occur at 8:30 a.m., 10:00 a.m., noon, 2:00 p.m., 5:00 p.m., or 8:00 p.m. on VHF channel 6.
