Prince William Sound and Cook Inlet Areas 2025 Central Region Groundfish Fisheries Outlook

Emergency Orders # 2-GF-E-01-25 and # 2-GF-H-01-25

General

This annual advisory announcement provides a brief overview of Prince William Sound Area (PWS) and Cook Inlet Area (CI) commercial groundfish fishing opportunities for the 2025 calendar year.

Fishers, processors, and buyers must adhere to current Statewide Commercial Groundfish Fishing Regulations available online at: http://www.adfg.alaska.gov/index.cfm?adfg=fishregulations.commercial or from ADF&G offices in Homer, Cordova (907-424-3212), Anchorage (907-267-2104), and Soldotna (907-262-9368). Contact the Homer office with groundfish regulatory and registration questions (907-235-8191).

To land groundfish or halibut, an individual must possess a gear-specific, valid Commercial Fisheries Entry Commission (CFEC) interim-use or limited entry permit card. In addition, all vessels operating gear for groundfish, in state-waters fisheries, must possess a valid fishery-specific area registration from ADF&G. A vessel may be registered for only one groundfish registration area at a time and must check-out of an area prior to registering for another area. Area registrations may be obtained in person from ADF&G offices in Homer, Cordova, Anchorage, Soldotna, and Kodiak. A fisher must possess the appropriate CFEC permit card to register for PWS and CI groundfish fisheries. To register by fax or email, contact the Homer area office.

Allowable bycatch levels for groundfish species are set by Emergency Order (EO) and are listed below under the species headings for each respective management area. In CI all rockfish must be retained. In PWS all rockfish must be retained, except for in directed mechanical jig and hand troll fisheries, rockfish may be released using an approved deepwater release (DWR) device. Any rockfish bycatch in excess of the allowances listed below, must be weighed and reported on the fish ticket, by species, as an overage. Proceeds from overages are paid to the State of Alaska. The commissioner may, by EO, close and immediately reopen a season in which the bycatch limit for any species is adjusted.

The department has growing concerns about the status of rockfish stocks. The rockfish Guideline Harvest Level (GHL) in PWS was exceeded in 2022 and 2023. Management actions were taken in 2022–2024 to reduce rockfish bycatch. The rockfish GHL has not been exceeded in CI in recent years. To stay within the 2023 annual PWS rockfish GHL the department reduced rockfish bycatch limits, did not re-open the parallel Pacific cod season, and obtained emergency authority from the Board of Fisheries (BOF) to close areas to commercial fishing with specific gear types. In 2024, the department reduced rockfish bycatch limits. The department is seeking the assistance of fishery participants to set gear away from areas of known rockfish abundance. The BOF recently adopted a new regulation at the December 2024 meeting in Cordova, AK to allow ADF&G to close areas of concern in PWS, by gear type, to aid in rockfish conservation efforts.

Octopus may be retained as bycatch to directed PWS and CI groundfish fisheries up to 20% by weight of the directed groundfish harvest on board the vessel. In PWS, octopus may not be retained by vessels using jig gear.

Octopus will be closed to retention when the guideline harvest level (GHL) of 35,000 lbs is achieved in each respective area. At the 2024 BOF meeting in Cordova, AK a new regulation was adopted to open a directed octopus lair pot fishery in PWS. Please contact Homer ADFG for information regarding this new octopus fishery. See the octopus management plans for CI (5 AAC 38.360) and PWS (5 AAC 38.217) for additional information.

When a directed season is open for Pacific cod or walleye pollock, there are regulations for improved retention and improved utilization (IR/IU) of groundfish. Statewide regulation 5 AAC 28.070 (e) requires that a permit holder shall retain:

- (1) all Pacific cod brought on board a vessel when a directed fishery for Pacific cod is open and all Pacific cod brought on board a vessel up to the maximum retainable bycatch allowance of Pacific cod when a directed fishery for Pacific cod is closed;
- (2) all walleye pollock brought on board a vessel when a directed fishery for walleye pollock is open and all walleye pollock brought on board a vessel up to the maximum retainable bycatch allowance of walleye pollock when a directed fishery for walleye pollock is closed.

Under 5 AAC 28.075, a processor or processor's agent that purchases groundfish shall accept delivery of all Pacific cod and walleye pollock retained by the vessel under 5 AAC 28.070 (e).

Non-pelagic trawl gear may not be used to target groundfish in PWS or CI.

All groundfish species or fisheries not specifically mentioned in this document will be managed via the miscellaneous groundfish commissioner's permit requirements specified in PWS regulation 5 AAC 28.220 or CI regulation 5 AAC 28.379.

Anyone intending to fish in federal waters, further than 3 nautical miles (nmi) from shore, should contact the National Marine Fisheries Service (NMFS) for information prior to fishing.

State regulation 5 AAC 28.055 adopts by reference federal regulations at 50 CFR 679.24 (e), which require seabird avoidance measures (SAM) in all longline fisheries for groundfish and halibut in state waters except the Inside District of PWS and the Cook Inlet District of the Cook Inlet Area. All vessels participating in a parallel groundfish fishery, except those using jig or hand troll gear, must have a NMFS-approved vessel monitoring system (VMS). Prince William Sound Area

(*These regulations changed at the Cordova BOF meeting in December 2024. Please consult the new regulation book when it is issued in March 2025 or contact the Homer ADF&G office with questions.)

Prince William Sound Area (PWS; 5 AAC 28.200): all waters of Prince William Sound and waters of Alaska bounded on the west by the longitude of Cape Fairfield (148° 50.25′ W. long.) south to the latitude of Cape

Douglas (58° 51.10′ N. lat.), then west to 149° 00.00′ W. long., then south along 149° 00.00′ W. long., and on the east by 144° 00.00′ W. long. (Figure 1).

<u>PWS Inside District:</u> All waters of PWS enclosed by lines from Pt. Whitshed to Pt. Bentinck, Cape Hinchinbrook to Zaikof Pt., and Cape Cleare to Cape Puget.

PWS Outside District: All waters of PWS that are seaward of the Inside District are divided into two sections:

Eastern Section: waters of the PWS Outside District east of 147° 00′ W. long.

Western Section: waters of the PWS Outside District west of 147° 00′ W. long.

*Groundfish pot closures outlined in 5 AAC 28.250 (a) were repealed at the December 2024 BOF meeting in Cordova. Groundfish fishing closures related to Steller sea lion conservation include waters surrounding two rookeries in PWS, Seal Rocks and Wooded Island (Fish Island) (Figure 2). Directed commercial fishing for groundfish is closed to all gear types within 3 nmi of each of these rookeries. For specific regulatory language describing the closure areas, contact NMFS in Kodiak at (907) 481-1780 or consult the website at: https://alaskafisheries.noaa.gov/fisheries/sslpm.

Regulation 5 AAC 28.230 (j) prohibits a vessel from having more than one type of gear on board when participating in a groundfish fishery. There are two exceptions, 5 AAC 28.230 (k) where mechanical jigging machines and hand troll gear maybe used at the same time. *And 5 AAC 28.230 (l) where longline hook and longline pot gear maybe used at the same time while participating in the state managed sablefish fishery or the IFQ halibut fishery. The Prince William Sound Science Center (PWSSC) has acoustic receiver moorings set in PWS. Moorings are located near Hinchinbrook entrance, Montague Strait, the southwest passages (Latouche, Elrington, Prince of Wales, and Bainbridge), Canoe Pass/Cedar Bay, Red Head, Gravina, Glacier Island, NW Montague Strait (3 moorings), and Knight Island Passage (2 moorings). Maps are provided to pollock fishers at the time of registration, online at http://pwssc.org/locations-of-pws-acoustic-arrays/, and available by request at ADF&G offices in Homer, Cordova, and Anchorage; contact PWSSC in Cordova at 907-424-5800 for more information.

<u>Pollock*</u> – The directed pelagic trawl fishery will open at 12:00 noon January 20 with a 9.1 million lb guideline harvest level (GHL), a 5.6% decrease from the 2024 GHL. Fishers must obtain a 2025 Pollock Fishery Registration from ADF&G no later than 4:30 p.m. January 13. (5 AAC 28.206). Inseason catch reports, logbooks, and accommodation of an ADF&G observer upon request are required (5 AAC 28.263).

Pollock trip limits are 300,000 lb; harvest above 300,000 must be documented as an overage on the fish ticket. Overage proceeds must include a relative percentage of sold pollock consistent with disposition codes reported on the fish ticket for all pollock landed. Therefore, a pollock trip limit overage will contain both pollock with disposition sold and other applicable disposition codes (e.g. pollock destined for fish meal). Proceeds from trip limit overages shall be submitted to ADF&G in Homer by the processor by check with a copy of the fish ticket documenting the overage.

While the directed pollock fishery is open, all pollock caught as bycatch must be retained by fishers participating in other groundfish fisheries in PWS. After the directed fishery closes, pollock must be retained up to the maximum allowable bycatch amount of 20% to other open directed groundfish fisheries (5 AAC 28.070 (e)). ADF&G will solicit bids for a test fishery, which funds research in PWS, before the season begins; the available harvest will be 900,000 lb.

<u>Sablefish*</u> – PWS limited entry sablefish permit holders must obtain a 2025 PWS Sablefish Registration no later than 5:00 pm, April 1 to participate (5 AAC 28.206). Fishery season dates will open in conjunction with the IFQ opening of sablefish and close December 31 by regulation unless closed earlier by EO. (5 AAC 28.210(b)). The GHL is divided among registered permit holders under the shared quota system described in regulation 5 AAC

28.272. CFEC regulations allow an interim-use or limited entry permit holder to use a vessel with an overall length greater than the vessel category for which the permit is designated.

The 2025 PWS sablefish GHL is 264,000 lb, up 8.2% from 2024. After the registration deadline, ADF&G will distribute an announcement the first week of April outlining 2025 harvest allocation by permit class.

A prior notice of landing (PNOL) is required for the PWS sablefish fishery. Fishers are required to contact ADF&G at least 6 hours prior to landing by telephoning (907) 424-7225 or by setting up alternative communication plans before fishing. Details to report are outlined on the registration.

Log sheets are required in this fishery (5 AAC 28.272 (f)) and must be submitted with fish tickets within seven days of landing. E-logbooks may be an option in 2025. Please contact Homer ADF&G for information regarding e-logbooks. Sablefish in PWS may not be retained as bycatch. Whale depredation on hooked sablefish has been an ongoing issue, resulting in the removal of unknown numbers of sablefish during longline retrieval; fishers may document this by reporting any whale depredation on log sheets. In the PWS sablefish fishery, groundfish pots must be longlined (5 AAC 28.230 (c)(d)).

Rockfish* – Rockfish in PWS may only be retained as bycatch to other directed groundfish and halibut fisheries. The PWS Rockfish Management Plan, 5 AAC 28.265, requires full retention of all rockfish, with the exception of rockfish caught on mechanical jig and handtroll gear. Rockfish caught as bycatch using mechanical jig or handtroll gear may be released using an approved DWR device. Approved DWR device videos can be found here and information about them may also be obtained at the Homer ADF&G office. Rockfish bycatch limits in PWS are 20% to directed sablefish, 5% to directed Pacific cod, 10% to other directed groundfish and halibut, and 0.5% to the pelagic trawl pollock fishery. All rockfish harvest must be weighed by species and reported on a fish ticket. Proceeds from the sale of any bycatch overage must be paid to the State of Alaska. There is an overall rockfish GHL of 150,000 lb and a 5-day trip limit of 3,000 lb. Black and dark rockfish in federal waters of PWS are managed by ADF&G and accrue to the GHL. The department is seeking the assistance of participants in directed fisheries to set gear away from areas of known rockfish concentrations. Voluntary measures taken to aid in the conservation of rockfish are greatly appreciated.

<u>Lingcod*</u> – ADF&G manages lingcod in both state and federal waters. Lingcod may not be retained until July 1. Participants in the PWS directed lingcod fishery must obtain a 2025 Directed Lingcod Registration. GHLs for the directed fishery are 7,300 lb for the Inside District and 25,300 lb for the Outside District. Lingcod may be retained as bycatch up to 20% of the directed groundfish or halibut species on board a vessel after July 1. Lingcod have a minimum size requirement of 35 inches (5 AAC 28.270). ADF&G will also issue an EO to require all lingcod be landed with the head on and the vent intact, for gender determination, so that biological sampling goals can be met. A PNOL is required for the PWS directed lingcod fishery. Fishers are required to contact ADF&G at least 6 hours prior to landing by telephoning (907) 226-2121 or by setting up alternative communication plans before fishing. Details to report are outlined on the registration.

<u>Pacific cod*</u> – Two Pacific cod fishery seasons, the "parallel" and the "state-waters," occur within PWS state waters. These seasons have distinct requirements including different registrations and gear limits. Parallel Pacific cod season participants must obtain a 2025 PWS Parallel Season Pacific Cod Registration, while state-waters Pacific cod season participants must obtain a separate 2025 PWS State-waters Season Pacific Cod Registration. Each registration is specific to gear type, and PWS is designated an exclusive registration area for vessels using longline hook and pot gear, and a nonexclusive registration area for vessels using jig gear, during the state-waters season. PWS is a nonexclusive registration area during the parallel season for all gear types. A 60-pot limit and pot tags are required for pot vessels participating in the state-waters season. Since March of 2023, groundfish pots may be longlined in the state-waters Pacific Cod fishery (5AAC 28.230 (c)). Each end of the buoy line must

be marked and each pot must have an ADF&G issued pot tag attached. Further marking regulations are defined in 5AAC 28.230 (d)(2)).

The parallel Pacific cod season will open January 1 and will be managed concurrently with NMFS management of the Pacific cod fishery in adjacent federal waters of the Central Gulf of Alaska (CGOA). The federal CGOA Pacific cod "B" season for vessels using jig gear may open June 10, whereas for pot and longline gear the "B" season may open September 1. Longlining groundfish pots is not permitted in the parallel Pacific cod season.

The state-waters Pacific cod season will open to longline hook gear seven days following the closure of the parallel longline season, which coincides with the federal less than 50 foot hook-and-line gear sector, but not earlier than the individual fishing quota (IFQ) halibut season opening date. The state-waters season will open to jig gear and/or pot gear 24 hours following the closure of the parallel season to those respective gear types. Participants in the state-waters PWS Pacific cod season are required to check in with the department prior to each fishing trip by telephoning (907) 424-7225; this requirement is detailed on the area registration form.

The 2025 PWS Pacific cod state-waters season GHL is 1,612,130 lbs. New for 2025, the GHL is allocated 50% to pot and jig gear combined (806,065 lb) and 50% to longline gear (806,065 lb). The 2025 GHL decreased 0.4% from the 2024 GHL. A subsequent advisory announcement will provide additional fishery information.

Refer to the "General" section at the beginning of this document for VMS and seabird avoidance requirements for parallel fishery participants and information on the NMFS Observer Program. The state-waters Pacific cod season will open in the Inside District, Western Section of the Outside District, and that portion of the Eastern Section of the Outside District west of Hook Point (146° 15.12' W. long.). Regulations require that Pacific cod be retained up to the maximum bycatch allowance when a directed fishery for Pacific cod is closed, and that all Pacific cod caught incidentally to other groundfish fisheries must be retained when a directed fishery for Pacific cod is open (5 AAC 28.070 (e)). In PWS, the maximum bycatch allowance of Pacific cod is 20% to other directed groundfish and halibut fisheries for vessels using longline hook, pot, or jig gear.

<u>Skates</u> – There is no directed season for skates in PWS; however, skates may be retained as bycatch as a percentage, by weight, of directed groundfish or halibut on board a vessel. The allowable bycatch limit for combined skate species is 5%, which mirrors the federal 2025 maximum retainable amount (MRA) for the GOA.

<u>Sharks</u> – There is no directed season for sharks (including spiny dogfish) in PWS; however, these species may be retained as bycatch up to 15%, by weight, of directed groundfish or halibut on board a vessel.

Cook Inlet Area

Cook Inlet Area (5 AAC 28.300): all waters of Alaska within Cook Inlet and along the outer Kenai Peninsula north of the latitude of Cape Douglas (58° 51.10' N. lat.) and west of the longitude of Cape Fairfield (148° 50.25' W. long.) (Figure 3).

<u>Cook Inlet District</u>: Waters of Alaska in the Cook Inlet Area north of a line from Cape Douglas to Point Adam (59° 15.27' N. lat.).

<u>North Gulf District</u>: Waters of Alaska in the Cook Inlet Area north of the latitude of Cape Douglas, and west of the longitude of Cape Fairfield excluding the Cook Inlet District.

Pollock – There is no directed fishery for walleye pollock in the Cook Inlet Area. However, pollock must be retained up to the maximum bycatch allowance of 20% to other directed groundfish or halibut fisheries (5 AAC 28.070 (e)).

<u>Sablefish</u> – Participation in the fishery requires a Cook Inlet Area 2025 Sablefish Registration. The fishery has a vessel trip limit of 3,000 lbs of sablefish (round weight) in any two consecutive days. Sablefish may be retained in the state waters of the Cook Inlet Area only by a vessel registered for the directed fishery and only when the directed season is open.

The 2025 Cook Inlet sablefish fishery will open April 15 with a GHL of 116,000 lbs, a 0.9% increase from the 2024 GHL. The GHL is adjusted annually by applying the relative change each year in the NMFS CGOA ABC, which is derived from NMFS stock assessment surveys and adopted by the NPFMC.

A PNOL is required for the Cook Inlet Area sablefish fishery. Fishers are required to contact ADF&G at least 6 hours prior to landing by telephoning (907) 226-2121 or by setting up alternative communication plans before fishing. Details to report are outlined on the registration.

Sablefish pots may be longlined; no more than 15 groundfish pots may be attached to the same longline and at least one buoy, properly marked, must be attached to each end of the longline (5 AAC 28.330 (c)). In addition, there are log sheet requirements in this fishery (5 AAC 28.360 (b)) and log sheets must be submitted with corresponding fish tickets within seven days of landing.

Rockfish — The Cook Inlet Rockfish Management Plan (5 AAC 28.365) requires full retention of all rockfish caught and mandates that proceeds from the sale of any bycatch overage be paid to the State of Alaska. Rockfish bycatch allowances are 10% during directed groundfish and halibut fisheries. A jig-only (mechanical jig or hand troll gear) fishery targeting pelagic shelf rockfish (PSR), defined in 5 AAC 39.975 as black, dark, dusky, widow, yellowtail, and deacon rockfish, opens July 1 and allows rockfish bycatch up to 20% for non-PSR species. Participation in the directed fishery requires a Cook Inlet Area 2025 directed rockfish fishery registration. There is a 150,000 lb GHL for all rockfish species combined in the Cook Inlet Area. Black and dark rockfish in federal waters are managed by ADF&G as part of the Cook Inlet Area GHL. There is a 1,000 lb trip limit in the Cook Inlet District and a 4,000 lb trip limit in the North Gulf District; trip limits apply to a five consecutive day period.

A PNOL is required for the Cook Inlet Area directed pelagic rockfish fishery. Fishers are required to contact ADF&G at least 6 hours prior to landing by telephoning (907) 226-2121 or by setting up alternative communication plans before fishing. Details to report are outlined on the registration. In addition, there are log sheet requirements (5AAC 28.365 (e)(1)); log sheets must be submitted with corresponding fish tickets within seven days of landing.

<u>Lingcod</u> – ADF&G manages lingcod in both state and federal waters. Lingcod may not be retained until July 1. Directed fishing for lingcod is restricted to harvest with jig (mechanical and hand troll) gear and has a 52,500 lb GHL. Participation in the directed fishery requires a Cook Inlet Area 2025 lingcod fishery registration. Lingcod may be retained as bycatch after July 1 to other directed fisheries at the 20% level and only when the directed lingcod fishery is open. There is a minimum size requirement of 35 inches (5 AAC 28.370). Resurrection Bay, north of a line from Aialik Cape to Cape Resurrection, is closed to retention of lingcod.

A PNOL is required for the Cook Inlet Area directed lingcod fishery. Fishers are required to contact ADF&G at least 6 hours prior to landing by telephoning (907) 226-2121 or by setting up alternative communication plans before fishing. There is no log sheet requirement for the directed lingcod fishery, but participants are encouraged to use log sheets from the directed rockfish fishery to provide the department with more information on lingcod.

<u>Pacific cod</u> – Two Pacific cod fishery seasons, the "parallel" and the "state-waters," occur within Cook Inlet Area state waters. These seasons have distinct requirements including different registrations and gear limits. Parallel Pacific cod season participants must obtain a Cook Inlet Area 2025 Parallel Season Pacific Cod Registration. State-waters Pacific cod season participants must obtain a separate Cook Inlet Area 2025 state-waters Pacific Cod Season Registration. Each registration is specific to gear type, and CI is designated an exclusive registration area during the state-waters season. A 60-pot limit and pot tags are required for pot vessels participating in the state-waters season; pots may not be longlined for Pacific cod in the Cook Inlet Area.

The parallel Pacific cod season will open January 1 for vessels using pot, jig, and longline gear and will be managed concurrently with NMFS management of the Pacific cod fishery in adjacent federal waters of the Central Gulf of Alaska (CGOA). The federal CGOA Pacific cod "B" season for vessels using jig gear may open June 10, whereas for pot and longline gear the "B" season may open September 1.

Twenty-four hours following the closure of the initial parallel Pacific cod seasons for pot and jig gear, the respective state-waters Pacific cod seasons for pot and jig gear will open in the Cook Inlet Area. Longline gear is not a legal gear type in the Cook Inlet Area state-waters Pacific cod season.

The Cook Inlet Area GHL for the 2025 season is 1,695,300 lb. The GHL will be allocated 85% to pot gear (1,441,005 lb) and 15% to jig gear (254,295 lb); only 25% of the total GHL may be harvested by vessels >58 feet fishing with pot gear (423,825 lb). The 2025 GHL decreased .04% from the 2024 GHL. A subsequent advisory announcement will provide additional fishery information.

Regulations require that Pacific cod be retained up to the maximum bycatch allowance when a directed fishery for Pacific cod is closed, and all Pacific cod caught incidentally to other groundfish fisheries must be retained when a directed fishery for Pacific cod is open (5 AAC 28.070(e)). The maximum bycatch allowance of Pacific cod in the Cook Inlet Area is 20% to other directed groundfish and halibut fisheries for vessels using longline, pot, or jig gear.

Refer to the "General" section at the beginning of this document regarding the VMS and seabird avoidance requirements for parallel fishery participants and information on the NMFS Observer Program. Portions of both Kachemak Bay and Kamishak Bay are closed to fishing with groundfish pot gear. Fishers are reminded to check with groundfish staff in Homer or consult regulations regarding specific areas of the Cook Inlet Area closed to fishing with pot gear (Figure 4).

Pacific cod fishing closures related to Steller sea lion conservation establish longline and pot gear closures within 10 nmi, in addition to no-transit zones within 3 nmi, of Sugarloaf Island and Outer Pye Island (Figure 3). For specific regulatory language describing the closure areas, contact NMFS in Kodiak at (907) 481-1711 or consult the NMFS website at: https://alaskafisheries.noaa.gov/fisheries/sslpm.

<u>Skates</u> – There is no directed season for skates in the Cook Inlet Area; however, skates may be retained as bycatch as a percentage, by weight, of directed groundfish or halibut on board a vessel. The allowable bycatch limit for combined skate species is 5%, which mirrors federal 2025 MRA for GOA.

<u>Sharks</u> – There is no directed season for sharks (including spiny dogfish) in the Cook Inlet Area, however, these species may be retained as bycatch up to 15%, by weight, of directed groundfish or halibut on board a vessel.




Figure 1.-Prince William Sound Area boundaries and groundfish districts.




Figure 2.—Prince William Sound Area closures to groundfish pot gear, groundfish fishing around Steller sea lion rookeries, and to the state-waters Pacific cod season.




Figure 3.-Vessel no-transit and fixed gear Pacific cod fishing closure zones around Steller sea lion rookeries within the Cook Inlet Area.




Figure 4.-Kachemak Bay groundfish pot closure area with coordinates for the Cook Inlet Area.
