## Lower Cook Inlet Salmon Fishery Advisory Announcement #18

LCI salmon harvest is ongoing with eight commercial purse seine and twelve commercial set gillnet permit holders reporting deliveries. As of July 23, a total of 199,365 sockeye had been harvested from the Southern District by commercial purse seine permit holders. Aerial surveys of the Eastern, Outer, and Kamishak districts generally documented anticipated levels of sockeye, pink, and chum salmon returns for this date.

**<u>OUTER DISTRICT:</u>** Effective at 6:00 AM Friday, July 25 regulatory closed waters at the head of McCarty Fjord (5AAC21.350(f)(11)) are rescinded until further notice. Remaining waters of the East Nuka Subdistrict north of 59° 33.60' N. latitude remain open on a daily schedule of 6:00 AM to 10:00 PM fishing periods. An aerial survey flown on July 22 documented that sockeye passage from Delight Creek into Delight Lake is impeded due to dry weather conditions.




Figure 1.- Portion of the Eastern District showing Aialik Bay Subdistrict and Petersen Lagoon.

**EASTERN DISTRICT:** Waters of the Aialik Bay Subdistrict remain open to commercial common property purse seine harvest on a daily schedule of 6:00 AM to 10:00 PM fishing periods. This includes the waters of Petersen (Aialik) Lagoon south of 59° 53.84' N. latitude (Figure 1).

An aerial survey flown on July 22 documented 5,100 sockeye salmon in Aialik Lake. This is more than the previous survey on July 15 where 4,150 were counted. Both counts are within the 3,400-11,000 fish SEG range for this species and system. There has been no commercial common property salmon harvest in 2025 from the Eastern District.

**KAMISHAK DISTRICT:** Subdistricts of the Kamishak District excluding the McNeil River Subdistrict, the Paint River Subdistrict, and the Kirschner Lake special harvest area remain open on a daily schedule of 24-hour fishing periods.

The Chenik Subdistrict including the portion of Chenik Lagoon east of 154° 08.33' W. long. is open on a schedule of daily 24-hour fishing periods. The Chenik video counting station has documented 8,000 salmon entering Chenik Lake towards an SEG range of 2,900 – 13,700 fish. An aerial survey conducted on July 15 documented over 22,000 sockeye salmon in Chenik Lagoon. The last delivery from this area occurred on July 14. Harvest from the Chenik Subdistrict is confidential due to fewer than three permits reporting deliveries.

**SOUTHERN DISTRICT: Purse seine:** In the Southern District, the following areas remain open on a schedule of Monday, Wednesday, and Friday 16-hour commercial fishing periods beginning at 6:00 AM on those days,

-the Halibut Cove Subdistrict,

-the Tutka Bay Subdistrict, excluding the Tutka Bay Hatchery special harvest area (SHA) southeast of a line between a point at 59° 28.22' N. Lat., 151° 27.85' W. Long., and another point at 59° 28.76' N. Lat., 151° 26.75' W. Long., and

-the Neptune Bay and China Poot Bay sections, excluding the Hazel Lake and China Poot SHAs. Commercial common property seine harvest to date from the Southern District is 199,365 sockeye, 423 pink, 164 chum, 89 coho, and 2 Chinook salmon.

Set gillnet: Waters of the Southern District identified in 5AAC 21.330(b)(1) remain open to commercial set gillnet harvest on a regular schedule of two 48-hour fishing periods per week beginning at 6:00 AM on Mondays and Thursdays as defined in 5AAC 21.320(a)(3). Harvest from last week's fishing periods is shown in Table 1,

As a reminder, unless otherwise specified in regulation or by emergency order, commercial fishing for salmon is prohibited at all times within 500 yards of the fresh water of a salmon stream and over the beds or channels of streams and rivers at all stages of the tide. Fresh water is considered separated from salt water, at the mouth of streams and rivers, by a line drawn between the seaward extremities of the exposed tideland banks at the present stage of the tide, (5AAC 39.975(a)(26)).

#### The next scheduled commercial salmon fisheries announcement is anticipated to be on Friday, August 1.
