UPPER COOK INLET COMMERCIAL FISHING ANNOUNCEMENT No. 25 EMERGENCY ORDER NUMBER 2-F-H-26-25

Commercial salmon fishing with drift gillnets will be open from 7:00 a.m. to 11:00 p.m. on Friday, August 1, 2025, in State of Alaska waters of the Expanded Kasilof, Expanded Kenai, and Anchor Point sections only. Record harvest under statistical code 244-57.

Additionally, commercial salmon fishing with drift gillnets will be open from 7:00 a.m. to 7:00 p.m. on Monday, August 4, in State of Alaska waters of drift gillnet Area 1, Area 3, the Expanded Kenai, Expanded Kasilof, and Anchor Point sections. Commercial fishing will then be extended from 7:00 p.m. to 11:00 p.m. on Monday, August 4, in State of Alaska waters of the Expanded Kasilof, Expanded Kenai, and Anchor Point sections only. Record harvest is the statistical area that fish are predominantly harvested in (Figure 1.). If fishing predominantly in the Kenai, Kasilof, and AP sections, then use statistical code 244-57.

As a reminder, per the *Kenai River Late-run King Salmon Stock of Concern Management plan*, drift gillnet fishing is prohibited within 2-miles of the Kenai Peninsula shoreline.

Through July 30, the cumulative sockeye salmon escapement estimate for the Kasilof River was 1,065,849 fish and the current mean run timing projection of escapement is approximately 1.3 million sockeye salmon which exceeds the biological escapement goal of 140,000–320,000 sockeye salmon. Through July 30, the cumulative sockeye salmon escapement estimate for the Kenai River was 2,790,067 fish and the current mean run timing projection of escapement is approximately 4.8 million sockeye salmon which exceeds the inriver run goal of 1.2-1.6 million sockeye salmon. Fishing in the above-described waters is warranted to target sockeye salmon returning to the Kasilof and Kenai rivers.

Fishermen and processors are reminded of the legal requirement to report all commercially harvested salmon on a fish ticket, whether sold or kept for personal use, using the correct statistical fishing area or areas (5 AAC 39.130(c)(7)).

Please check with the appropriate federal agency regarding fishing in the Exclusive Economic Zone (EEZ).
