# Sand Point Commercial Salmon Fishery Advisory Announcement #22

For Emergency Order #4-FS-M-SP-20-25

The current commercial salmon fishing period by **purse seine and set gillnet gear** will be extended from 9:00 p.m. Saturday, August 16 until further notice in the following districts and sections:

Unimak District, Southwestern District, South Central District, and the Shumagin Islands Section of the Southeastern District.

Commercial salmon fishing by **purse seine and set gillnet gear** will be allowed for 96 hours from 8:00 p.m. Saturday, August 16 until 8:00 p.m. Wednesday, August 20 in the following sections:

Beaver Bay, Balboa Bay, Southwest Stepovak, Northwest Stepovak, and East Stepovak Sections of the Southeastern District

The current commercial salmon fishing period by **drift gillnet gear** will be extended from 9:00 p.m. Saturday, August 16 until further notice in the following districts and sections:

Unimak District and Ikatan Bay Section of the Southwestern District.

Commercial salmon fishing by **purse seine, set gillnet, and drift gillnet gear** will be allowed for 84 hours from 6:00 a.m. Monday, August 18 until 6:00 p.m. Thursday, August 21 in the Urilia Bay and Bechevin Bay Sections of the Northwestern District.

#### **Closed Waters:**

Waters within 500 yards of the Christian Lagoon exit channel terminus at the ocean shoreline are closed to commercial salmon fishing.

In the waters of Peterson Lagoon from a point located 500 yards upstream from the lagoon outlet channel terminus at the ocean shoreline are closed to commercial salmon fishing.

All closed waters will be as described in the regulation book or as adjusted by emergency order.
