# 2026 Dutch Harbor Subdistrict State-Waters Pacific Cod Guideline Harvest Level Announced

The 2026 Dutch Harbor Subdistrict (DHS) state-waters Pacific cod guideline harvest level (GHL) for pot gear is 40,559,000 pounds and 100,000 pounds for jig gear. The DHS includes state waters east of 170° W long, west of 162° 30' W long, and south of 55° 30' N lat. The DHS south of 53° 06.11' N lat is closed to fishing. The DHS state-waters Pacific cod season for pot gear will open by advisory announcement 7 days after closure of the initial federal Pacific cod season for the Bering Sea and Aleutian Islands hook-and-line and pot catcher vessel less than 60 feet in overall length (OAL) sector. The DHS state-waters Pacific cod season for jig gear will open May 1, 2026.

The DHS is an exclusive registration area for pot gear and nonexclusive for jig gear. A vessel may not be registered for more than one exclusive registration area during a calendar year. However, a vessel may register for one state-waters Pacific cod exclusive registration area and any nonexclusive state-waters Pacific cod registration area within the same year. Vessels must be registered for the state-waters fishery prior to participating. Before registering, fishermen must obtain a 2026 interim-use permit card for miscellaneous finfish from the Commercial Fisheries Entry Commission. Fishermen entering or exiting the state-waters Pacific cod fishery must notify ADF&G in Dutch Harbor and deliver all unprocessed Pacific cod on board.

Vessels 58 feet or less OAL using pot gear or mechanical jigging machines may participate in DHS state-waters Pacific cod fishery. Gear is limited to 60 groundfish pots or 5 mechanical jigging machines. Buoy identification tags are required for all pot gear and are available at Alaska Department of Fish and Game (ADF&G) offices in Dutch Harbor and Kodiak for \$1.50 per tag. Buoy tags may be available in other ports as well, please contact ADF&G in Dutch Harbor for more information. Cash, check, and credit card are acceptable payment methods for purchasing buoy tags.

During the DHS state-waters Pacific cod season, National Marine Fisheries Service (NMFS) Steller sea lion (SSL) protection measures are in effect. SSL closures are as specified for the Bering Sea in Table 5 of 50 CFR part 679, except the SSL haulouts listed in Table 5 for Umnak Island/Cape Aslik at 53° 25.00' N lat, 168° 24.50' W long, Uliaga at 53° 04.00' N lat, 169° 47.00' W long to 53° 05.00' N lat, 169° 46.00' W long, and Kagamil at 53° 02.10' N lat, 169° 41.00' W long are closed to the taking of Pacific cod within three nautical miles. SSL protection measures are also in effect as specified in Table 12 of 50 CFR part 679. **Tender Vessels:** Tender vessel operators must obtain a tender vessel registration for the state-waters Pacific cod fisheries and must use the tLandings electronic reporting application for groundfish delivered to a tender vessel (5 AAC 28.033(a) and 5 AAC 39.130(b)).
