**Sand Point Commercial Salmon Fishery Advisory Announcement #02 Revised**  
**For Emergency Order #4-FS-M-SP-02-26**

Regulations adopted by the Alaska Board of Fisheries in February of 2026 will not be in effect at the start of the fishing season, therefore monofilament is not permitted in set gillnet gear and all salmon, including king salmon, caught from June 1 through June 28, must be retained and reported on fish tickets.

The South Unimak and Shumagin Islands June fisheries will open to commercial salmon fishing for **set gillnet gear only** during the following times and dates:

From 6:00 a.m. Saturday, June 6 until 10:00 p.m. Monday, June 8

The South Unimak and Shumagin Islands June fisheries will open to **drift gillnet and set gillnet gear** during the following times and dates:

From 6:00 a.m. Wednesday, June 10 until 10:00 p.m. Saturday, June 13

From 6:00 a.m. Monday, June 15 until 10:00 p.m. Thursday, June 18

From 6:00 a.m. Saturday, June 20 until 10:00 p.m. Tuesday, June 23

From 6:00 a.m. Thursday, June 25 until 10:00 p.m. Sunday, June 28

The South Unimak and Shumagin Islands June fisheries will open to **purse seine gear only** during the following times and dates:

From 6:00 a.m. Wednesday, June 10 until 2:00 a.m. Saturday, June 13

From 6:00 a.m. Tuesday, June 16 until 11:59 p.m. Thursday, June 18

From 8:00 a.m. Saturday, June 20 until 11:59 p.m. Tuesday, June 23<sup>a</sup>

From 8:00 a.m. Thursday, June 25 until 11:59 p.m. Sunday, June 28<sup>a,b</sup>

<sup>a</sup> If the June 18 trigger of 300,000 chum salmon is reached, this period will be reduced to 44 hours.

<sup>b</sup> If the June 23 trigger of 450,000 chum salmon is reached, this period will be closed.

The June fishery occurs in the following districts and sections:

Otter Cove and Cape Lutke Sections of the Unimak District (Sanak Island Section closed)

Bechevin Bay Section of the Northwestern District

Southwestern District

West and East Pavlof Bay sections of the South Central District

Shumagin Islands Section of the Southeastern District

The Sanak Island Section will be closed to commercial fishing for salmon during the month of June. Additionally, there are two chum salmon triggers that are set in place. The first trigger will occur if 300,000 chum salmon are harvested by June 18. If the trigger is met or exceeded, then the last two openings for the purse seine gear will be reduced by 50%. The second trigger will occur if 450,000 chum salmon are harvested by June 23. If the trigger is met or exceeded, the final fishing period for purse seine gear will be closed.

If the early run sockeye salmon escapement at the Chignik weir is projected to not be met, then fishing time for purse seine gear could be reduced by 50% in the Shumagin Islands Section during the June 16 fishing period. Subsequent fishing

periods could also be reduced by 50 % to meet the lower bound of the Chignik River early run sockeye salmon escapement goal. If the lower bound of the Chignik River early run sockeye salmon escapement goal is projected to be met, then these restrictions could be lifted.

Seine gear is not allowed in the South Central District or the Volcano Bay and Belkofski Bay Sections of the Southwestern District, excluding the waters north of a line from Vodapoini Point to Bold Cape.

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
