2016 Yukon River Fall Salmon Fishery News Release # 7 Yukon River District 1 Commercial Period 3

Districts Affected: Lower Yukon Area Emergency Order # 7

The 2016 fall chum salmon preseason run projection, based on the summer chum to fall chum salmon relationship, is for a run size between 800,000 and 900,000 fish. This level of abundance should be sufficient to provide for escapement, an above average subsistence harvest, and a surplus available for commercial and personal use purposes. The estimated fall chum salmon passage at the mainstem sonar near Pilot Station through July 23 is estimated to be 275,8000 fish, which is above the historical median of 63,100 fish for that date. The first pulse of fall chum salmon entered the Yukon River on July 18 and finished passing the mainstem sonar near Pilot Station yesterday.

District 1 Commercial Fishing:

Commercial fishing will be open for one period in the <u>Set Net Only Area</u> of District Y-1 on Monday, July 25 from 12:00 noon until 12:00 midnight. This will be a 12-hour commercial fishing period for the <u>Set Net Only Area</u> with gillnets restricted to six-inch or smaller mesh.

The remainder of District Y-1 will be open to commercial fishing on Monday, July 25 from 3:00 p.m. until 12:00 midnight This will be a 9-hour commercial fishing period with gillnets restricted to six-inch or smaller mesh.


Verbal reports from first District 1 commercial opening on July 21 indicate a preliminary harvest of 9,992 fall chum salmon from 174 deliveries. The preliminary cumulative commercial harvest of fall chum harvest to date in District 1 is 32,628 fish.

District 1 Subsistence Fishing:

Subsistence salmon fishing in District 1 is open during the fall season 7 days per week, 24 hours per day with gillnets restricted to a maximum mesh size of 7.5 inches, except for 12 hours before, during, and 12 hours after each commercial fishing period. In District 1, subsistence salmon fishing will close at 12:01 a.m. Monday, July 25, and reopen at 12:00 noon Tuesday, July 26. Fishermen may use 4-inch or smaller mesh size gillnets to target non-salmon species during subsistence salmon closures.
