### Prince William Sound Salmon Fishery News Release #39

**COPPER RIVER DISTRICT:** Copper River District will open at 7:00 am on Thursday, July 28 for a 24-hour commercial fishing period.

Cumulative Miles Lake sonar count through 7/26 was 796,903 fish whereas the anticipated range for this date is 650,684–1,007,097. The 0600 count for 7/27 was 187 fish. For the week ending July 23, the actual Copper River delta survey count was 25,470 sockeye salmon versus an anticipated range 32,059–75,775 fish. Poor lighting, due to solid and low cloud cover, limited visibility in index systems during this survey. A preliminary harvest estimate from the 24-hour period that started on Monday, July 25 was 9,150 sockeye, 1,255 pink, and 199 coho salmon with 92 deliveries reported.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent with commercial periods until the Copper River District is closed at the end of the season. Subsistence users may obtain subsistence permits during regular business hours. The Cordova ADF&G office is open to the public Monday - Friday, 8:00 am - 12:00 pm and 1:00 pm - 5:00 pm. **Subsistence permits are not available outside of regular office hours.**

**BERING RIVER DISTRICT:** Bering River District, west of a longitude line at 144° 33.60' W., will open at 7:00 am Thursday, July 28 for a 24-hour commercial fishing period. Bering River sockeye salmon run timing overlap has increased and open area within the district will likely remain reduced until escapement indices support additional fishing effort.

**COGHILL DISTRICT:** Waters of the Coghill District are closed to common property commercial drift gillnet and purse seine fishing. To date, 8,662 sockeye salmon have passed the Coghill River weir versus an anticipated range of 18,307–54,921 fish.

**ESHAMY DISTRICT:** Main Bay Subdistrict, excluding the MBH THA, SHA, and AGZ, will open to commercial gillnet harvest for a 24-hour period starting at 8:00 am on Thursday, July 28. The MBH THA, SHA, and AGZ will open to commercial gillnet harvest for a 48-hour period starting at 8:00 am on Thursday, July 28. **The AGZ will open to DRIFT GILLNET permit holders only during this fishing period.** Preliminary sockeye salmon contributions to Eshamy District period 15 (7/18 to 7/20) were 90% MBH and 10% wild fish. A preliminary harvest estimate from the 84-hour period that started on Thursday, July 21 is 12,960 sockeye, 2,280 pink, and 38 chum with 112 deliveries reported.

**MONTAGUE DISTRICT:** The Port Chalmers Subdistrict, north of 60°12.56' N. lat. and within 0.5 miles of Montague Island, will open to drift gillnet fishing for 64 hours beginning at 8:00 am on Thursday, July 28. The Montague District will close to commercial drift gillnet fishing after the Thursday fishing period. The western boundary of the Port Chalmers Subdistrict is defined by lines from 60°20.00'N., 147°26.59'W. to 60°14.75'N., 147°35.35'W. to 60°02.50'N., 147°44.41'W. Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect through 11:59 pm Saturday, July 30.

**UNAKWIK DISTRICT:** Waters of the Unakwik District are closed to commercial fishing for the 2016 season.

**SEINE FISHERIES:** This announcement will provide time and area specifics for commercial purse seine fishing opportunity in eastern PWS on Thursday, July 28.

VFDA currently estimates there are approximately 500,000 pink salmon holding within the SHA. VFDA needs approximately 475,000 pink salmon; 25,000 for cost recovery and 450,000 for broodstock.

Aerial surveys of Eastern PWS were flown on July 23 and indicated that pink and chum salmon escapements are currently within anticipated ranges for the date. The department does not anticipate that these stocks will sustain a consistent schedule of openings at this time. The Coghill River weir has passed 17,204 pink salmon as of 7/24, which is above average for this date.

PWSAC has observed small numbers of returning pink salmon at AFK, WNH, and CCH. PWSAC reports that cost recovery of pink salmon is expected to stand down until harvest is warranted.

**EASTERN DISTRICT:** Waters in the Eastern District, North of the latitude of the Rocky Point light, will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 28.

**Waters of Port Valdez east of a line from a point on shore at 61°04.85' N. lat., 146°30.62' W. long. to a point on shore at 61°08.05' N. lat., 146°27.00' W. long., will be closed to commercial fishing during this period.**

**Waters inside of the following Eastern District Salmon Harvest Task Force (SHTF) markers will be closed during this period:**

- (1) **Galena Bay:** waters east of a line from a shore marker at approximately 60°56.87' N. lat., 146°39.87' W. long. to a shore marker at approximately 60°56.55' N. lat., 146°39.65' W. long.;
- (2) **Jack Bay:** waters south and east of a line from a shore marker at approximately 61°02.34' N. lat., 146°35.27' W. long. to a shore marker at approximately 61°02.17' N. lat., 146°39.77' W. long.;
- (3) **Sawmill Bay:** waters north of a line from a shore marker at approximately 61°02.71' N. lat., 146°46.44' W. long. to a shore marker at approximately 61°02.58' N. lat., 146°47.07' W. long.

**NORTHERN DISTRICT:** Waters of the Northern District will be closed until further notice.

**SOUTHEASTERN DISTRICT:** Waters of the Southeastern District will be closed until further notice.

**Permit holders are advised that unscheduled announcements based on current escapement data may occur at any time inseason either establishing an additional period or extending an open period.**

**The next scheduled seine fisheries announcement is anticipated to be at 2:00 pm Thursday, July 28.**

**The next scheduled gillnet fisheries announcement is anticipated to be at 2:00 pm Saturday, July 30.**

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit [http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap\\_reporting\\_form.pdf](http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf) for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All** MMPA category fisheries are liable for incidentally taking ESA listed species.

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals.
