**ALASKA BOARD OF GAME  
 November 16, 2018 - Teleconference**

*Meeting Summary*

The Board of Game (board) met by teleconference on Friday, November 16, 2018. Seven board members were present: Chairman Ted Spraker, Vice-Chairman Nate Turner, Stosh Hoffman, Teresa Sager Albaugh, Karen Linnell, Larry Van Daele, and Tom Lamal. The purpose of the meeting was to address several Agenda Change Requests that were submitted by the November 1, 2018 deadline for the board’s meetings in January and March 2019.

With consideration of the criteria under the Agenda Change Request Policy (5 AAC 92.005), the board took action on the following ACRs. ACR #1 was previously considered and accepted by the board in February 2018 and is included as proposal 129 in the board’s 2018/2019 proposal book.

**Miscellaneous Business**

Commissioner Nomination Committee: Board members Tom Lamal, Karen Linnell, and Chairman Ted Spraker will serve on the committee for the commissioner nomination process; member Van Daele will serve as an alternate. The committee will work with members of the Board of Fisheries’ Joint Board subcommittee. The commissioner appointment process is established under Alaska Statute 44.39.030 which states, “The Governor shall appoint the commissioner of fish and game from a list of qualified persons nominated by the Board of Fisheries and Game meeting in joint session, subject to the right of the governor to request additional nominations.” Chairman Spraker provided a tentative timeline. He said Boards Support would soon distribute a notice about the commissioner nomination process and the solicitation for candidates. The suggested deadline for submitting resumes would be December 14. The committee would be expected to have up to two meetings to review resumes and conduct interviews in late December and early January, depending on the number of candidates. Under the tentative timeline, the Joint Board meeting will be held January 16, 2019, when the Board of Game members are returning from the board meeting in Petersburg to join the Board of Fisheries members, who will be at regulatory meeting in Anchorage. Chairman Spraker commented that the Joint Board would interview the final candidates.
