Alaska Board of Game Interior and Eastern Arctic Region Meeting Pike's Waterfront Lodge, Fairbanks, AK March 6-14, 2020

Meeting Summary

The Board of Game (board) convened the Interior and Eastern Arctic Region meeting on Friday, March 6, 2020 in Fairbanks at Pikes Waterfront Lodge. Seven board members were present: Chairman Ted Spraker, Vice-Chairman Stosh Hoffman, Larry Van Daele, Tom Lamal, Jerry Burnett, Orville Huntington, and Allen Barrette.

The meeting opened with introductions and board member ethics disclosure statements, followed by agency reports. The list of agency reports is provided on page 10. Public testimony began Friday, March 6 at 4:30 PM, and concluded Monday, March 9 at 1:35 PM. The board heard from 94 testifiers, of which 15 were advisory committee representatives (see RC 54).

Board deliberations began Saturday afternoon, following public testimony. The board considered 124 proposals, adopting 37, and deferring three to a future meeting. Board action for each proposal is provided below as: C = carried; A = amended; F = Failed; D = deferred; and NA = no action.

Regionwide & Multiple Units (13 proposals)

The board clarified intent regarding the changes to the Dalton Highway Corridor Management Area which will be scheduled for the 2021 Statewide Regulations meeting. Although the need for a committee or working group was discussed during the oral hearing, the board did not establish one. Both ADF&G and the board recognized the complexity of the issue and the need to involve different levels of government, individuals, and organizations with any proposed changes. Member Al Barrette volunteered to be the board's contact for the department on this topic.
