How best to share this work with subcommittee so as not to duplicate efforts?

The Council moved to request a report to continue the process of evaluating the estimation and impact of high seas bycatch of salmon on run returns as well as continued support for research funding to better understand the diverse causes of low salmon returns to these regions.

Specifically, the Council requests:

An updated bycatch impact (AEQ) analysis which includes current genetic stock identification information and an updated age/length composition for Chinook salmon along with estimates of how many Chinook salmon taken as bycatch in the Bering Sea pollock fishery would have returned to Western Alaska Chinook salmon stock groupings. The analysis should include a PSC harvest rate analysis and an estimate of the Chinook salmon bycatch impacts to each specific stock grouping at the current cap levels and at actual bycatch levels in recent years.

The Council also requests that the report include recommendations to evaluate impacts of chum salmon bycatch in the pollock fishery with currently available data. A stock status update of Western Alaska Chinook and chum salmon stocks.
