Subsistence and Personal Use Salmon Fishing Permit Conditions

In addition to the general permit conditions listed on and issued with the 2025 Southeast Alaska Subsistence and Personal Use Salmon Fishing Permit, the following permit conditions apply to the Ketchikan management area. - 1. Chinook salmon may not be retained in the Unuk River, Naha River, and Yes Bay personal use fisheries. Chinook salmon may be retained in the Herring Bay terminal harvest area (THA). For all other areas, Chinook, coho, steelhead, trout, and char may be taken only incidentally by gear operated under the personal use fishing guidelines of this permit. The possession limit for Chinook salmon is 2 fish and for coho salmon is 6 fish.
- 2. In subsistence fishing areas, Chinook salmon, trout, and char may be taken only incidentally by gear operated under the subsistence fishing guidelines of this permit. The possession limit for Chinook salmon is 2 fish.
- 3. Sockeye salmon may not be retained as incidental catch.
- 4. In the Ketchikan management area, drift gillnets may only be used in Yes Bay, and in the Nakat Inlet, Neets Bay, Kendrick Bay, and Herring Bay THAs. Drift gillnets may not exceed 50 fathoms in length, except for in the Herring Bay THA where drift gillnets may not exceed 10 fathoms in length. There are no mesh restrictions. The permit holder must be present while the gillnet is in operation.
- 5. In subsistence fishing areas, the personal use fishery is closed to the taking of salmon when the subsistence salmon fishery is closed.
- 6. The Klawock River drainage upstream of the Klawock River Bridge is **CLOSED**. From January 1 to August 31, subsistence and personal use salmon gear may only be operated from a vessel with a motor of no greater than 50 horsepower.
- 7. Leask Creek, Mahoney Lake and Creek, Helm Bay Creek, and the marine waters within 500 yards of the terminus of these streams are **CLOSED**.
