Second DRAFT Spend Plan for funds appropriated to address the 2021 and 2022 Upper Cook Inlet (UCI) East Side Set Gillnet (ESSN) salmon fishery disaster determination. NOAA Fisheries has allocated \$11,484,675 for these fishery disasters. The spend plan informs the federal grant application submitted by Pacific States Marine Fisheries Commission (PSMFC) to NOAA Fisheries and is subject to change based on approval of the final grant.

Written comments are requested on all elements of the proposed spend plan and should be as specific as possible. Comments will be posted as received online and therefore, ADF&G requests that no business proprietary information, copyrighted information, or personally identifiable information be included in written comments. Comments must be sent by September 17, 2024, for consideration in the final draft spend plan.

Process to develop the spend plan: ADF&G posted an initial draft spend plan in July 2024 and received 61 written comments (Appendix 1). In response to public comment, ADF&G provides the following rationale and revisions to the second draft spend plan:

Request for Comment

ADF&G removed the request for comments regarding inclusion of the sport fishing businesses. No comments were received from sport fishing guides or business regarding incurred losses and there is no proposed sport fishing allocation in this fishery disaster spend plan.

Crew payments

• ADF&G acknowledges the recommendation in public comment on the initial draft spend plan that permit holders should be delegated responsibility for making crew payments. However, a verification process to ensure every permit holder distributes crew funds would be administratively burdensome and would delay full disbursement of permit holder funds. To ensure that affected crew members are equitably included in relief payments, ADF&G proposes that PSMFC will distribute crew payments in a manner similar to the process established for permit holders.

Processor Allocation

ADF&G received multiple, mixed public comments requesting an increase, no change, or decrease in the processor allocation. Increased costs and losses realized by processors due to COVID safety measures were considered in the CARES Act funding program and relief for these operating challenges is not the intended purpose for these fishery disaster funds. ADF&G recommends maintaining the 25% allocation to processors to bring the processing sector up to \sim 15.8% of its recent historical value. The 25% allocation is consistent with the proportion of funds allocated to the processing sector in the 2018/2020 ESSN and UCI fishery disaster spend plan and also mitigates a higher proportion of the sector's losses relative to the benefits provided in the 2018/2020 disaster allocation.

• Estimated exvessel processor losses in the initial draft spend plan were reported for 2022 only (~\$8.65 million) and did not include the combined losses for both 2021 and 2022 (~\$14 million). Estimated first wholesale losses of ~\$18 million are based on the proportion of ESSN sockeye salmon processed by eligible processors relative to all UCI sockeye salmon processed.

Research

• ADF&G proposes a competitive bid proposal process to fund research projects based on public comments opposing a non-competitive process where projects would be identified and directly funded in the spend plan.

Guiding principles for disaster fund distribution: Disbursement of funds is intended to 1) assist fishery participants harmed by the 2021 and 2022 ESSN salmon fishery disasters and 2) improve fishery information used to assess and forecast future fishery performance and to develop management approaches that avoid and/or mitigate the impacts of future fishery disasters that cannot be prevented.

The proposed categories and allocations reflect comments received on the initial draft of this spend plan and the 2018 and 2020 Upper Cook Inlet salmon fishery disaster spend plan.

Commission to administer the federal grant

The impact of the fishery disaster created significant loss of income to those involved in the harvesting and processing sectors and to the communities in which the cultural and basic economic structure is the marine economy. A portion of these funds will be allocated to research activities that promote restoration of the fishery or prevent a similar failure in the future, but they will also be used to help assist the fishing communities that were affected by this fishery resource disaster by recognizing the loss of incomes. These direct payments will compensate participants consistent with fishery investments and/or historical fishery performance. Historically one of the purposes of disaster funding was to get funds to communities and fishermen as fast as possible. Direct payments provide that method.

<u>Research – 10% (\$1,125,000)</u>: Research funds are intended to support projects that improve available fishery information and help prevent and/or mitigate future fishery disasters. Based on public comment, ADF&G proposes a competitive process to distribute research funds through an open competitive bid

process administered by PSMFC. The review panel for proposed projects may include both agency and non-agency experts. Federal agencies, such as the US Fish and Wildlife Service, are not eligible to receive federal fishery disaster grant funds.

The following research themes were suggested by ADF&G staff and initial draft public comments and are informed by the previous spend plan as priorities for funding:

- Research that improves understanding of the relative importance of specific mechanisms that drive productivity of Kenai late-run Chinook salmon, which could include:
 - how ocean/climate conditions impact future runs;
 - o freshwater and early marine survival bottlenecks, habitat use, and movement patterns; and
 - the role of diet, health, and disease on the survival and spawning success of Kenai late-run Chinook salmon.
- Research to inform non-adult abundance estimates of Kenai Chinook salmon that can be used in developing or improving forecasting tools.
- Improved methods for estimating adult salmon harvest and abundance including genetic analysis for stock composition and further assessment and review of the Kenai late-run Chinook salmon estimates of abundance for all age classes.
- Research to investigate how large sockeye salmon escapements to the Kenai and Kasilof rivers may influence productivity and future returns.
- Investigations of Chinook salmon habitat, including intertidal, nearshore, riverine rearing areas, and spawning areas. Research on smolt outmigration and survival.
- Continued evaluation of alternative gear types aimed at reducing harvest of weak stocks in marine fisheries.

<u>Communities – 3% (\$343,000):</u> ADF&G is proposing direct payments to municipalities and boroughs that rely on revenue generated from ESSN salmon landings and other economic activities related to the salmon fisheries. These local government entities were negatively impacted by the fishery disaster because fishery revenues comprise a significant portion of local operating budgets and are used to support education, public works, ports and harbors, and other services. The state's Fishery Business tax rate is 3% for shore-based landings and is shared 50/50 with the state and municipalities/ boroughs where the landings occur. If landings occur in the bounds of a municipality and borough, landing tax revenues are shared 50/50 between each entity.

Proposed eligibility criteria for communities:

- 1. Fish ticket port of landing data must show that salmon from the 2021 or 2022 ESSN salmon fishery were landed in the community.
- 2. Estimated loss in gross revenue value for salmon landed in the community from 2021 and 2022 ESSN fisheries combined must be at least \$10,000. The estimated loss in gross revenue is calculated by subtracting the value of the fishery in the disaster year from the previous five-year average, excluding the disaster years of 2018 and 2020.

Disaster funds for communities are proposed to be distributed **pro rata** to each community's demonstrated loss relative to the total loss of all eligible communities. Based on the criteria, three municipalities and one borough may be eligible for community-designated funds: City of Homer, City

of Kenai, City of Soldotna, and the Kenai Peninsula Borough based on landings in Kasilof and Ninilchik.

<u>Harvesters – 62% (\$7,036,764)</u>: This category includes permit holders and crew. The total estimated loss in gross revenue for the 2021 and 2022 ESSN fishery disasters is \sim \$14 million dollars. Funds allocated to the harvesting sector are intended to mitigate this loss by providing funds to bring the harvesting sector up to 49.4% of the sector's recent historical value.

ADF&G proposes direct payments to commercial fishery permit holders and crew who meet all eligibility criteria. Commercial Fisheries Entry Commission (CFEC) permit information, fish ticket data from commercial salmon landings, buoy sticker registration, and CFEC gross earnings data are proposed to be used to determine eligibility for permit holders. Permit holders can apply for each year in which they meet eligibility criteria but cannot apply as both a permit holder and crew member in the same year. Eligibility for crew will be verified using ADF&G commercial crew license or CFEC permit data and an affidavit from the permit holder or vessel owner. An affidavit form will be provided by PSMFC in the application materials.

ADF&G proposes to divide the harvester allocation into two pools, one for S04H permit holders (90%) and one for crew members (10%). Direct payments to minors are not authorized by the terms of the Federal grant but may be authorized to guardians in the same household on behalf of an eligible minor.

ESSN Permit Holders - 90%

Proposed eligibility criterion for permit holders:

• Individual must have registered a valid S04H CFEC permit and purchased a buoy sticker for the Upper Subdistrict in 2021 and/or 2022 as demonstrated by ADF&G Division of Commercial Fisheries records. A permit is considered valid if fees were paid to renew the permit.

Funds are proposed to be paid to the person listed as the 2021 and/or 2022 'Permit holder' and temporary emergency transfer permit holders (transferees) in the CFEC database. Permit holders who certified they were unable to participate to qualify for an emergency transfer and permit holders who permanently transferred a permit away before registering and purchasing a buoy sticker in 2021 and/or 2022 will not receive payments.

Each permit holder who meets the eligibility criterion is proposed to receive an equal payment for each eligible permit in each year for which they purchased an Upper Subdistrict buoy sticker. A total of 422 permits in 2021 and 402 permits in 2022 were registered to fish with an Upper Subdistrict buoy sticker. **ADF&G is requesting public comment on the proposed criterion and whether fishery participation during the disaster year should be required for CFEC permit holders in addition to the purchase of a buoy sticker.**

<u>ESSN crew – 10%</u> East Side set gillnet crew must meet the following criteria to be eligible for a proposed **equal payment** of the ESSN crew funds for each year in which they participated as fishing crew.

Proposed ESSN crew eligibility criteria:

1. Crew member must have held a 2021 and/or 2022 commercial crew license or a 2021 and/or 2022 CFEC permit for any fishery. This information will be verified using the ADF&G Licensing database and the CFEC permit database.

2. Crew member must provide information to show they participated as fishing crew in the 2021 and/or 2022 ESSN salmon fishery for a <u>qualified S04H permit holder</u>, based on an affidavit from the permit holder.

Anyone qualified for disaster funds as an ESSN permit holder or transferee cannot qualify as crew in the same year.

Processors – 25% (\$2,840,000): ADF&G proposes direct payments to processing companies. ADF&G estimated total loss in first wholesale revenue for sockeye salmon for all eligible processors at ~\$18 million dollars. This estimate was calculated by first determining the proportion of ESSN sockeye salmon delivered to each eligible processor as a function of all UCI sockeye salmon delivered in each year using fish ticket data. Those proportions were applied to the first wholesale value for sockeye salmon reported in the COAR production data for each eligible processor in each year. Funds allocated to the processing sector are intended to mitigate this loss by providing funds to bring the processing sector up to 15.8% of the sector's recent historical value.

COAR buying data are proposed to be used to determine eligibility and payment for processors because those data are linked to where the salmon were harvested, and the scope of this fishery disaster includes the 2021 and 2022 ESSN salmon fisheries. ADF&G proposes disaster payments to processing companies be proportional to each company's demonstrated loss relative to the total loss of all eligible processing companies.

Proposed eligibility for processors:

- 1. Processing company must have purchased ESSN salmon in 2021 and/or 2022.
- 2. Processing company must have a demonstrated loss in final exvessel value for salmon purchased by the company from the 2021 and 2022 ESSN fisheries. The estimated loss in value is calculated by subtracting the final exvessel value of the fishery in 2021 and 2022 from the previous five-year average, 2014 through 2017 and 2019.

Disaster payments are proposed to be **pro rata** to each company's demonstrated loss relative to the total loss of all eligible processing companies. Based on the criteria, a total of seven processing companies may be eligible for processor funds.

<u>Program Support – <0.1% (\$11,000)</u>: ADF&G proposes allocating funds for staff working on fishery disaster plan development and implementation in coordination with Pacific States Marine Fisheries Commission.

Darion Jones,

Under Guiding principles for disaster fund distribution 2) ADF&G states "to improve fishery information used to assess and forecast future fishery performance:

- The Department should undergo a complete review on historical harvest allocation and economic analysis cause and affect consequences over the last 5, 10, and 20 years by regulatory changes and Management of salmon resources. Comparative analysis by salmon stock allocation changes by Area, Stat Areas, and Sub Districts, and South of Kasilof River vs. North of Kasilof River stock composition changes over historical timeframes; there is no longer a traditional Set Gillnet fishery operating and unfortunately fishery disasters do not fully encompass the aforementioned changes and historical losses appropriately. The reallocation analysis and harvest estimates yearly changes to all other fisheries on salmon bound for the Kasilof and Kenai Rivers; i.e. reallocation to UCI drift gillnet, personal use dip net and gillnet fisheries. Unfortunately, this straight forward analysis wasn't performed in the disaster declaration.
- I oppose any "inclusion of sport fishery businesses" in the spend plan. This group has overall benefited from ESSN closures annually with the vast amounts and gross amounts of harvest numbers from the reallocation of sockeye salmon and increased daily bag limits, expanded dip net fisheries, trips, drop offs, and these business have alternative salmon resources to operate nearly year round on Coho, enhanced king salmon fisheries, halibut and rockfish, etc. When and if the sport fisheries are closed to the taking of sockeye salmon similar to ESSN closures is the only time this subject should be brought up period.

Under Research:

- I would support a complete independent scientific "review of the Kenai late-run Chinook salmon estimates for all age classes. A complete review of the stock assessment programs estimates on all age classes in annual returns.
- Habitat studies and spawning area studies; i.e. successful spawning and intertidal zone studies over smolt out migration and survival. U.S. Fish and Wildlife should do research programs.
- "Management Strategy Evaluation analysis" on mixed stock management approach taken by ADF&G and the Board of Fisheries has been a disaster compared to all other Areas/Districts/ or Sub <u>districts in</u> fisheries in Cook Inlet and all Areas within Region 2, including the management

of Upper Cook "salmon stocks" as defined, compared to any commercial management over stocks of concern. Gear and time and Area opening have not been similarly affected or caused fishery disasters. Note: All age classes (except 1.1) are part of escapements except on the Kenai River; 15.000 "large kings" is equivalent to 28,000 king salmon returns based on all classes which puts recent escapement at the upper end of the escapement goal. The Deshka River, Anchor River, Susitna River, Nushagak River, Chignik River, and Karluk River Chinook goals are all based on 1.2 age classes and larger – including stock of concern stocks. To be clear, ADF&G created large fish goal and thereby ESSN fishery disaster declarations over the last 6 years,

- I oppose the concept of "alternative gear" a bridge to nowhere to benefit a few and completely counter to legislature's passage and intent under The Limited Entry Act and White Act of 1924 by Congress for the Set Gillnet fishery in Upper Cook Inlet. What's next dip net fisheries for the Nushagak District and Bristol Bay commercial fisheries, Chignik and Kodiak Seiners?
- I oppose non-competitive bid process. ADF&G Commissioner's office history has already awarded a non-competitive research project to a Canadian firm in the amount of \$250,000 dollars in 2023 under the premise of net depth study which resulted in failure over results and suppositions. This was done under political pressure. Meanwhile, by comparison. ADF&G couldn't fund the decade's long O.T.F. boat in 2024.

Processors 25% amount.

- This amount should be reduced to 20 22.5% as a reallocation of commercial salmon to the Drift fleet with extra time and Area openings and occurred in 2021and 2022 and processor's processed this reallocation sockeye salmon harvest levels and benefitted and should be taken into account. Numerous smaller processor's benefited from the reallocation from ESSN sockeye salmon fisheries to the personal use and sport fisheries.
- The processor's with established buying stations and receiving station along the ESSN should be recognized and therefore recognize those buying stations and receiving stations affected in 2021 and 2022 and should be included in the direct payments to processors scenario.

It's been 6 years since the 2018 fishery disaster declaration and not one dime has distributed to ESSN fishermen and crew. Based on accountability and performance should affected fishermen expect some kind of relief from 2021 and 2022 by 2027 timeframe?

Dear Mr. Jones,

Thank you for the opportunity to comment on the initial Draft Spend Plan for the 2021 and 2022 Upper Cook Inlet Eastside Setnet salmon fisheries disaster. My family and I operate a setnet fishing operation in Upper Cook Inlet, and the past ten-plus years have presented significant challenges, preventing a predictable business environment. I would like to briefly comment on various aspects of the initial spend plan.

Allocation

Harvesters

I understand that disaster funding is not intended to fully compensate for business losses and that in the past, it aimed to cover around 49% of recent values for the harvesting sector. I am comfortable with the proposed 62% allocation for permit holders and crew.

Processors

I also support the 25% allocation for processors. They have undoubtedly faced drastic reductions in production and profitability due to severe restrictions placed on the ESSN fishery. The unpredictable business environment complicates decisions on crew, packing supplies, and shipping. There have been discussions suggesting that a fairer calculation of their losses would be based on first wholesale values rather than just the COAR report.

Research

In the past, I have fully supported science and research to provide managers and policymakers with the best available data, particularly regarding forecasting, accurate stock assessments, and real-time in-season data. This helps manage the fishery and ensure its sustainability both biologically and economically. I remain supportive of research that aims for these goals. However, I am concerned that we are moving towards political narratives rather than sound scientific management. I do not support funding for alternative gear types, especially since the ESSN has already significantly reduced its gear under the guise of king salmon conservation, resulting in fewer harvest opportunities. We do not yet know the current exploitation rate on king salmon with this reduced level of gear. We should continue using the current gear before considering alternatives. Zero exploitation of king salmon is not realistic. It is generally accepted that the current king salmon situation results more from unfavorable ocean conditions than from incidental harvest by the ESSN fleet.

Sportfishing Businesses

The ADF&G requested comments on including sportfishing businesses as a separate category within this spending plan. Reviewing the Governor's disaster request and the Secretary of Commerce's approval of the federal disaster under the Magnuson-Stevens Act, both were based on losses incurred by the ESSN fishery and the processing sector. Including sportfishing businesses at this stage would not be appropriate.

I appreciate the opportunity to comment on this initial spend plan and hope it does not get bogged down in bureaucratic red tape. I also hope that any research activities lead to the return of a healthy resource and a robust fishing economy.

The Alaska Salmon Alliance (ASA) would like to share our concerns and suggestions about the Federal Fishery Disasters Draft Spend Plan for 2021 and 2022 Upper Cook Inlet Eastside Setnet salmon fisheries disaster.

By way of background ASA, an Alaska based nonprofit entity, advocates for and promotes science-based salmon policies that will result in long term economic opportunities and benefits for Alaska's coastal communities for future generations. To this end, ASA endeavors to develop positive working relationships with policy makers. Founded and supported by regional salmon processors and harvesters, ASA also collaborates with other organizations to protect and enhance the salmon resources of the region, sustain a year-round fishery economy and to insure the future of the Alaska salmon industry.

Our main concerns and suggestions are as follows:

- Allocation Formula: We concur with others in the salmon processing industry that the allocation share to the UCI salmon processing sector should be raised from 25% to 35%. We think this is appropriate since the harvest sector share is based on ex-vessel revenue losses. However, the most appropriate measure of losses in the processing sector should be the first wholesale value. The approach would use the price each sector is paid for fish: ex-vessel for harvesters and wholesale for the processing sector. The use of only ex-vessel prices for both sectors results in a negative bias against processors so adjustment to the percentage of allocation to processors would be a reasonable and efficient remedy to such bias. We also believe this would also be more in line with federal disaster funding's goal to mitigate harm to those who experienced adverse economic impacts as a result of a fishery disaster.
- Inclusion of Sportfishing Businesses: It is our understanding that the U.S. Secretary of Commerce approved the fishery disaster for the 2021-2022 Upper Cook Inlet Eastside setnet fishery and related businesses, such as processors, that experienced significant revenue losses. It is also our understanding that Governor Dunleavy, in his request for fishery disaster funding under the Magnuson-Stevent Act use loss of revenue to the eastside setnet fishery as the basis for the request, and ultimate approval, of the disaster request. It appears that inclusion of a large

segment of the fishing community that was not considered or factored into the funding request would result in prejudice to those who the disaster funds target. This perspective is reinforced in that the drift fishery was also not included in either the funding request or grant of funding. Accordingly, we believe the sportfish business sector of the fishery should be excluded from the disaster funding plan.

- Research: Although we support further research in the UCI salmon fishery, we have significant reservations that disaster funded research projects be directed solely by ADF&G. We believe history demonstrates the Cook Inlet salmon fishery is driven by allocative and political priorities rather than sound science. It appears research into stock composition and passage estimates for late-run Kenai Chinook salmon of all age classes and implications of continuous large over escapements of sockeye into the Kenai and Kasilof rivers to often take a back seat to continuous gear and opportunity restrictions on one harvest sector ESSN. In our view, any research funds should, at a minimum, be overseen by industry representatives that have unfortunately borne the brunt of many fishery disasters over the past years. This critical oversight would mitigate "solutions" that do little to investigate root causes of the fishery disasters such as how escapement goals are set and measures, unreasonable burdens on certain sectors of the industry and impacts of unbridled growth in the habitat areas salmon rely on to reproduce. Oversight should include representatives from processors and harvesters from throughout Cook Inlet. In our view, those most impacted by research decisions should be at the table along every step of the research process.
- Other allocations: Allocations for administrative costs and losses incurred by municipal entities seem reasonable.

We appreciate the opportunity to comments on this important program. The negative and long-term impacts of fishery disasters in Cook Inlet across many sectors of the industry can't be understated. We think with an equitable allocation formula that focuses disaster funds on those they were intended for along with proper oversight of disaster funded research will result in a plan that meets the intent of the fishery disaster funding program.

Dear Mr. Jones:

Thank you for the opportunity to comment on the Federal Fishery Disasters Draft Spend Plan for 2021 and 2022 UCI ESSN Salmon. OBI Seafoods has been actively involved in processing salmon in the Cook Inlet region since 1973, contributing significantly to the local community and economy. Our processing operation generates job opportunities, providing stable income and supporting local families. The economic ripple effect stimulates ancillary industries, fostering stability and growth.

Upon review of the proposed allocations, OBI has some concerns regarding the distribution.

OBI supports and appreciations the allocation of funds in the draft spend plan, particularly the earmarked 10% for research. We believe this allocation is fair and crucial for mitigating future fishery disasters. However, we would also like to see an emphasis of how over escapement will affect the Kenai and Kasiloff river systems carrying capacity for future Sockeye runs.

We also do not consider the proposed 62% Harvester / 25% Processor split a fair division. We respectfully request it be revised to a 52% Harvester / 35% Processor split. In 2021/22, the COVID-19 pandemic continued to hit processors financially. Where we recognize the impacts COVID had on harvesters, processors had to incur much greater expenses to ensure safe processing could take place.

To help mitigate COVID-19, OBI allocated funds to have a nurse practitioner on site, along with medical supplies, for a small in-plant clinic. To comply with state regulations during the pandemic, OBI continued to purchase protective supplies for our workforce, including nitrile gloves, COVID-19 test kits, and masks. Additionally, we organized our workforce's breaks and meals efficiently to reduce the risk of COVID-19. The Seward facility also added a security guard to ensure our employees stayed on site, keeping the community safe.

Processors like OBI Seafoods typically provide fishermen with advance funds before the season starts to cover expenses such as gear, insurance, repairs, and airfare. These advances, usually repaid through salmon harvests, were not reimbursed in the 2021/22 season due to the minimal returns. OBI faced significant economic losses due to this shortfall, which was exacerbated by having tenders and capacity in place for the anticipated volumes.

In conclusion, we express gratitude for the dedicated efforts in developing the spend plan and addressing the salmon disasters. We commend the inclusion of public comment solicitation and appreciate the opportunity to contribute our input.

Thank you for the opportunity to comment on the initial draft spend plan for the 2021 and 2022 Upper Cook Inlet east side set net salmon fisheries disasters. The Pacific Seafood Processors Association represents shoreside processing plants operating across Alaska, including one on the Kenai Peninsula which is historically dependent on commercial Cook Inlet salmon fisheries. Shoreside processing in Alaska is extremely capital intensive, with significant fixed costs just to open the door and take the first delivery, regardless of the strength of the fishery. Fishermen depend on viable shoreside markets across Alaska to deliver their catch, and communities depend on the jobs, fish tax and property tax revenue, and support service businesses resulting from local processing. The level of reductions in the years at issue represented a significant loss to processors dependent on these fisheries, and fewer and fewer processors are operating on the Kenai Peninsula, making the distribution of funds to retain local processing through these difficult times even more important.

Allocations

Overall, we support the State's intent that the vast majority of disaster funding be used for direct payments to affected fishery participants and communities, while also accommodating relevant research to improve fishery information used to assess and forecast future fishery performance. We also support the spend plan proposal to provide disaster payments to processing companies proportional to each company's demonstrated loss relative to the total losses of all eligible companies. This is consistent with the law and guidance governing federal disaster funding, which enables the federal government to help persons engaged in commercial fisheries by initiating projects, payments, or other measures to alleviate harm incurred as a direct result of a fishery resource disaster.

We continue to recommend that the state consider that processors and harvesters jointly share in the effort and risk in commercial fisheries, and to support an approach that attempts to evenly mitigate losses from the disaster to both sectors. In the initial spend plan, funds allocated to the harvesting sector are intended to mitigate losses by bringing the harvesting sector to 49.4% of the sector's recent historical value, and funds allocated to processors bring the sector up to 32.8% of its recent historical value. PSPA supports increasing the proposed processor allocation from 25% to 35% such that it is more aligned with the harvesting sector's compensated losses. Please also consider an increase in the processing percentage in light of the fact that the state is using ex-vessel revenue losses for both the

Ex-vessel value is appropriate for the harvesting sector given it reflects what they were paid for fish. To be comparable, first wholesale value is appropriate for the processing sector given it reflects what they were paid for fish. Ex-vessel value, by contrast, is a cost to the processing sector. We understand the limitations in linking first wholesale data from COAR to where the fish were caught, but had this more appropriate metric been used, we believe the identified losses to the processing sector would have been greater.

Research

We support using some of the funds for research but believe they should be focused on projects to improve fishery information used to assess and forecast future fishery performance and help prevent and/or mitigate future fishery disasters. We note these types of projects will support all salmon sectors in the region, whether subsistence, personal use, sport, or commercial. We don't support using research funds for the evaluation of new gear types or management strategy evaluations examining tradeoffs of different management approaches for the Upper Cook Inlet District. This seems insufficiently connected to the disaster itself, or the ability to avoid or mitigate disasters in the future, especially when this disaster (unexpected biomass decline and loss of access) was determined by the Secretary of Commerce to be due to "several factors such as unfavorable ocean conditions and prolonged marine heatwaves."¹

Including Sportfish Businesses

The initial spend plan also requested comment on whether to include sport fishing businesses as a separate category for funding in this spend plan. While sportfish businesses are also affected by salmon declines, this federal disaster under the Magnuson-Stevens Act is specifically based on and approved by the Secretary of Commerce for the 2021 and 2022 Upper Cook Inlet East Side set net commercial salmon fisheries. The disaster request from Governor Dunleavy, in which fisheries must meet revenue loss criteria to qualify for a disaster was only based on the commercial set net fisheries,² and the Secretary approved the disaster based on the 63% (2021) and 91% (2022) revenue losses only for the commercial fisheries. Including sport fishing businesses at this time would be inappropriate given the process and detracts from the fishing businesses whose losses were the entire basis for the determination.

Thank you for the opportunity to comment, and we appreciate ADFG's significant work toward developing the recent disaster spend plans, many of which we note are still awaiting funds to be released from OMB. The delays on the Federal agency end are extremely frustrating to fishery participants who have been waiting years to receive funds allocated quickly from Congress to respond to fishery disasters.

Dear Darion Jones,

We are the Executive Board of the Kenai Peninsula Fishermen's Association (KPFA), a non-profit 501(c) (6) commercial fisheries advocacy trade group representing Cook Inlet (CI) fishing families since 1954. KPFA's mission is "Ensuring the Sustainability of Our Fishery Resources." Our goal is to continue to strengthen our fishing community and to promote the economic stability of the Cook Inlet Setnet Fishery.

KPFA primarily represents salmon set net permit holders on the East Side of Cook Inlet. The geographical area of the fishery reaches from Ninilchik in the south to Boulder Point to the north, spanning more than 60 miles along Cook Inlet's Eastside. The salmon harvested by the East Side Setnet Fishery originate almost exclusively in the Kasilof and Kenai River systems.

Some 440 limited entry permit holders, each small businesspersons, fish for salmon in this area and are primarily Alaska residents (86% Alaska, 80% Central Peninsula residents).

We are writing today to express the Kenai Peninsula Fishermen's Association's position on the distribution of 2021 and 2022 NOAA Fisheries allocated Disaster Relief Funds in the amount of \$11,484,675.

Our consensus is that the disaster funds available for the 2021 and 2022 Upper Cook Inlet Eastside Setnet fishery disasters should be split evenly among the affected fisheries harvesters that requested the disaster declarations. The Eastside Setnetters. Permit holders at 90% and Crew members at 10%. Specifically, the only affected parties to the disaster were the East Side Setnet Fishery in 2021and in 2022. We agree that in 2021 and 2022 that the purchase of buoy stickers should be the qualifier for eligibility to receive disaster funds.

It is our consensus that in 2021 and 2022, permitholders paid their crews accordingly, and permit holders should handle any payout related to the 2021 and 2022 disaster funds. We are amenable to providing proof of payout to satisfy the intent of the disaster relief program. If funds are set aside for distribution to crewmembers, we want to have a say in how they're distributed. We expect any unclaimed funds to be returned to the East Side Setnet fishers equally. I.E. some crewmembers are paid on a flat rate, some on a daily rate, and others are paid on a percentage basis.

Lastly, our consensus is that if ADF&G is to receive any disaster funds for research, KPFA expects the funds to be spent on our impacted fishery and that KPFA has input on where and how all ADF&G research funds derived from the 2021 and 2022 disasters would be expended.

We believe that the investment in new or past alternative gear should be considered as a reimbursable expense to fishermen from the ADF&G research funds. As stated in the draft plan, "A portion of these funds will be allocated to research activities that promote **restoration** of the fishery or prevent a similar failure in the future, but they will also be used to help assist the fishing communities that were affected by this fishery resource

disaster by recognizing the loss of incomes." We propose gear reimbursement as a non-competitive process project if new alternative gear types become available for King Conservation.

My name is Ryan Stassel. I'm a third generation East Side setnetter and I am writing to express my strong opposition to the proposal of including the sportfishing sector in the 2021 and 2022 Upper Cook Inlet East Side Setnet (ESSN) salmon fisheries disaster relief spend plan.

The disaster relief funds for 2021 and 2022 were secured by the Kenai Peninsula Fishermen's Association (KPFA) after a rigorous application process, supported by extensive documentation proving the catastrophic losses suffered by the East Side Setnet fleet. These funds were rightfully allocated based on the significant financial harm experienced by setnetters.

However, it has come to our attention that ADF&G is considering sharing the 2021 and 2022 disaster funds with sportfishing businesses. This is a grossly unjust and unethical proposal, as sportfishing businesses did not go through the application process, did not suffer the same losses, and are currently thriving. Their inclusion in the relief plan diverts essential funds away from the East Side Setnet Fishery, which needs these resources to recover from the documented disasters.
