#### I. PROGRESS ON PROJECT OBJECTIVES DURING PERFORMANCE YEAR

OBJECTIVE 1: Population Size, Status, and Trend. Assess the size and status of each wolf population to determine the 5-year trend.

ACCOMPLISHMENTS: The annual statewide trapper questionnaire was distributed to obtain harvest information. Weather conditions allowed for track surveys of wolf numbers in Region 2 to be completed on portions of the Kenai Peninsula. Further flights when snow conditions allow have been planned to improve estimates of wolf abundance and pack dynamics in Unit 15. Other ongoing research may inform future efforts to estimate abundance. Anecdotal reports and harvest information indicate that population numbers are likely stable. Harvest increased slightly during this reporting period.

OBJECTIVE 2: Mortality/Harvest Monitoring and Regulations. Assess the number of wolf harvested by hunters and other sources of mortality that might have an impact on each population.

ACCOMPLISHMENTS: The annual statewide trapper questionnaire was distributed to obtain harvest information. Thirty-one (31) wolves were harvested in Region II during the reporting period: 4 wolves from Unit 6, 1 wolf from Unit 7, and 21 wolves from Unit 15. No wolves were harvested in Unit 14C for the tenth year in a row.

All wolves taken in Region II were presented to staff for specimen collection (if necessary) and sealing. Wolves taken in other parts of the state were often sealed in Region II offices.

All wolf pelts presented to ADF&G and appointed sealers were examined for the presence of lice. Wolves infected with lice currently exist on the Kenai Peninsula within Region II. Pelt condition continues to improve, and no lice were reported on the pelts harvested during the 2019/20 season.

OBJECTIVE 3: Wolf Management with Public Participation and Outreach. Manage each wolf population with an emphasis on engaging the public in management goals and objectives through public meetings, working groups, educational materials, and incentive programs.

ACCOMPLISHMENTS: ADF&G staff communicates with and attends meetings annually for 7 local Fish and Game Advisory Committees, the Alaska Board of Game, 2 Federal Regional Advisory Councils, the Federal Subsistence Board, Office of Subsistence Management, numerous local village councils and Native corporations about wolf management and to review and analyze regulation proposals for the Alaska Board of Game and the Federal Subsistence Board. Most information is focused on the Kenai Peninsula. The 2019/2020 cycle did not include any wolf proposals for Region II and participation was minimal.

Information and data were compiled to prepare 3 five-year wolf Management Reports and Operational Plans for Units 6, 7 and 15, and 14C. These reports will include historical and current data, management directions, methods, Board of Game actions, harvests and natural mortality, habitat assessments, and local and statewide non-regulatory issues.
