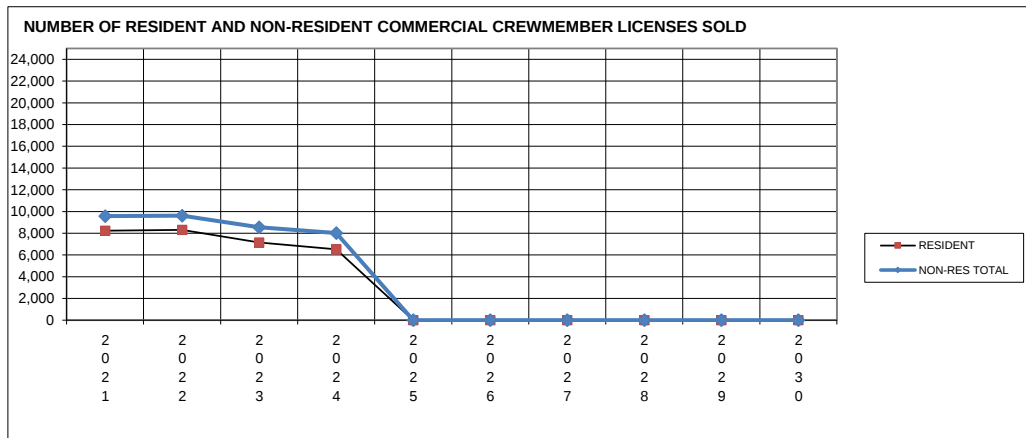

As of 2005 a 7-day crewmember license is available to residents and non-residents. Crewmembers began purchasing multiple 7-day licenses in lieu of an annual license. In 2015 a bill was passed restricting the purchase of 7 day licenses to one per year.
