

## Steese Highway Area Authorized Stream Locations [ reordered to approximate Steese MP]

**ADVISORY:** Numerous state and federal mining claims exist within this area. Please check with the Alaska Department of Natural Resources, Division of Mining, Land and Water and the U.S. Bureau of Land Management (BLM) for applicable claim status and obtain claim owner permission prior to recreational mining. In addition, some portions of waterbodies in the Steese Highway Area are on lands managed by the BLM; unless you have an approved mine plan on an existing federal mining claim, suction dredging is generally prohibited. You are advised to contact the BLM at (907) 474-2200 before going to the field. Only non-motorized gold mining (gold pans, metal detectors, hand-fed sluice and rocker boxes) is authorized on BLM land within the Nome Creek Mining Area.
