The Department of Law has reviewed the attached regulations of the Board of Fisheries against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Fisheries after the close of the public comment period.

The regulations amend Title 5 of the Alaska Administrative Code to update requirements related to fisheries in the Prince William Sound area. The updates include changes to various means and methods standards, setting requirements for Dungeness crab fishing, establishing a Prince William Sound District and Kayak Island District, updating limits related to food and bait fisheries, updating various commercial harvest requirements, and clarifying octopus fishery permitting and gear standards.

Both the November 3, 2024 public notice and February 24, 2025 order certifying the changes to regulations state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. After incorporating the corrections, the final regulations are 21 pages, not 22 pages as stated in the certification order.
