Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Board of Fisheries against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Fisheries after the close of the public comment period.

The regulations concern commercial, subsistence, and sport fisheries in the Bristol Bay area.

The September 24, 2025 public notice, December 7, 2025 supplemental notice, and the January 29, 2026 certification order all state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.

**5 AAC 06.341. Vessel specifications and operations.** (a) No vessel registered for salmon net fishing may be more than 32 feet in overall length, as measured in a straight line between the extremities of the vessel, except as provided in (b) of this section.

(b) The measurement of overall length of a vessel does not include anchor rollers, safety equipment, fish drop out baskets, gillnet rollers, gillnet roller mounts, outdrives, outdrive guards, outdrive mounting boxes, outdrive grounding guards, trim tabs, cooling systems, exhaust systems, and safety platforms, subject to the following limitations:

(1) an anchor roller may not extend more than 18 inches beyond the 32-foot overall length, and any portion that extends beyond the 32-foot overall length may not be more than 16 inches in width or height; no mechanical machinery of the anchoring system may be beyond the 32-foot overall length;

(2) no part of a cooling system may extend more than 18 inches beyond the 32-foot overall length;

(3) exhaust systems may not extend more than 18 inches beyond the 32-foot overall length;

(4) a fish drop out basket

(A) may not extend more than six feet beyond the 32-foot overall length;

(B) may be incorporated with the outdrive guard;

(5) a gillnet roller mount may not

- (A) extend more than 18 inches beyond the 32-foot overall length;
  - (B) provide any flotation, deck space, storage, or structural support to the vessel; or
  - (C) be used on the bow of a vessel;
- (6) no part of an outdrive may extend more than six feet beyond the 32-foot overall length;
- (7) no part of an outdrive grounding guard may extend more than five feet beyond the 32-foot overall length;
- (8) an outdrive guard
- (A) may be incorporated with a fish drop out basket;
  - (B) may not extend more than eight feet beyond the 32-foot overall length in any respect;
- (9) an outdrive mounting box may be no larger than 38 inches in height and 38 inches in width and may not extend more than six inches beyond the 32-foot overall length, per outdrive unit;
- (10) safety equipment may not extend more than 18 inches beyond the 32-foot overall length;
- (11) a safety platform
- (A) may not extend more than 36 inches beyond the 32-foot overall length;
  - (B) may not be more than 36 inches wide;
  - (C) may be mounted on the outdrive guard or fish drop out basket;

(12) a vessel may have up to two safety platforms on its stern if the safety platforms are located at the furthest point on opposite sides of the vessel;

(13) a trim tab may not extend more than 18 inches beyond the 32-foot overall length;

(14) if a trim tab incorporates jet reversing water flow ducting, the ducting may be no more than 18 inches aft of the 32-foot overall length.

(c) In this section,

(1) "anchor roller" means a device placed on the bow of a vessel used solely in the aid of deploying and retrieving anchor gear, and does not provide any flotation, planing surface, sea keeping ability, buoyancy, deck space, or structural support to the vessel;

(2) "cooling system" means condensers, hoses, tubing, or transom coolers attached to the stern or the trim tabs of a vessel used for refrigerated sea water systems or engines; a "cooling system" does not provide any flotation, sea keeping ability, deck space, or structural support to the vessel;

(3) "exhaust systems" means exhaust tips and baffles off the stern of a vessel;

(4) "fish drop out basket" means a device with non-metallic webbing that is skeletal in nature solely used to prevent the loss of fish from a gillnet after the fish leaves the water and before it is brought on board the vessel; a "fish drop out basket" does not provide any flotation, planing surface, deck space, storage, or structural support to the vessel;

(5) "flotation" means the structure or piece of equipment has a sealed void and is filled or built with material capable of adding positive buoyancy;

(6) "gillnet roller" means a device used solely in the aid of deploying and retrieving drift gillnet gear; a "gillnet roller" does not include any structure attached to the vessel

to mount a gillnet roller beyond the 32-foot overall length;

(7) "gillnet roller mount" means an attachment to the stern of a vessel to mount a gillnet roller beyond the 32-foot overall length;

(8) "outdrive" means part of the propulsion system of a vessel used for either steering or thrust; an "outdrive" does not provide flotation or planing surface to the vessel; an "outdrive" may include steering rudders for a vessel powered by propeller;

(9) "outdrive grounding guard" means a guard

(A) that may provide outdrive safety from grounding when located directly beneath an outdrive;

(B) of skeletal structure that is constructed of tubing or plate strips equal to or less than four inches in width, with a minimum of four inch spacing between;

(10) "outdrive guard" means a device of skeletal construction used solely to protect the outdrive unit of the vessel; an "outdrive guard" does not provide any flotation, planing surface, sea keeping ability, buoyancy, deck space, or structural support to the vessel;

(11) "outdrive mounting box" means an extension of the transom that the outdrive for the vessel extends through;

(12) "safety equipment" means equipment placed on the stern of a vessel for safe operation and includes ladders, lighting, and transducers; "safety equipment" does not provide flotation, planing surface, sea keeping ability, buoyancy, deck space, or structural support to the vessel;

(13) "safety platform" means usable deck space located on the stern of a vessel for safety purposes; a "safety platform" does not provide any flotation, planing surface, sea keeping ability, buoyancy, storage, or structural support to the vessel;

(14) "trim tab" means an extension of the bottom of the vessel, at the transom, that functions to provide trim to a vessel while underway; a "trim tab" does not provide any flotation or buoyancy. **This management plan is in effect until the lower bound of the sustainable escapement goal (SEG) adopted in 5 AAC 06.361(b)(1)(A) of 55,000 fish**

**(1) is met or exceeded in three consecutive years and is expected to be met in future years; or**

**(2) is met in four out of six consecutive years and is expected to be met in future years.**
