Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Board of Fisheries against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Fisheries after the close of the public comment period.

The regulations concern Yukon River king and fall chum salmon stock of concern management plans, Cook Inlet beach seine permits, commissioner experimental permits, and traditional knowledge.

The agency has alerted us that these regulations are time sensitive. *Accordingly, we respectfully request that they be filed on or before May 19, 2026.*

The public notice and the certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.

Title 5. Fish and Game.

Chapter 01. Subsistence Finfish Fishery.

5 AAC 01.249(1) is amended to read:

(1) the department shall use the best available data, including preseason projections, mainstem river sonar passage estimates, test fisheries indices, subsistence and commercial fishing reports, [AND] fish passage estimates from escapement monitoring projects, **and traditional knowledge** to assess the run size of chum salmon; **in this paragraph, "traditional knowledge" has the meaning given in 5 AAC 96.621;**

Chapter 05. Yukon Area.

5 AAC 05 is amended by adding a new section to read:

5 AAC 05.361. Yukon River King Salmon Stock of Concern Management Plan. (a)

The purpose of the Yukon River King Salmon Stock of Concern Management Plan is to provide management tools and guidelines to the department for the management of Yukon River salmon fisheries consistent with AS 16.05.258, 5 AAC 39.220, 5 AAC 39.222, the Pacific Salmon Treaty, and the seven-year agreement between this state and Canada to prohibit directed fishing for king salmon in the Yukon River main stem. While Yukon River king salmon are listed as a

stock of management concern, this plan is intended to ensure the sustained yield of king salmon stocks large enough to meet sustainable escapement goals, while allowing for harvest opportunity in the subsistence, sport, and commercial fisheries, as follows:

(1) in addition to management measures specified in 5 AAC 05.360 and educational permits provided under 5 AAC 93.212, the department may relax subsistence fishery management measures in specific tributaries within the state if updated stock composition and run assessment data indicate areas where specific restrictions are no longer needed to ensure the established escapement goals will be met;

(2) a fish wheel operated under this subsection must be operated as specified in 5 AAC 05.362(j)(1) and (2).

(b) The provisions of this management plan will remain in effect while Yukon River king salmon are listed as a stock of management concern. The department may recommend removal of this designation at the first Arctic, Yukon, Kuskokwim Board of Fisheries meeting when either of the following conditions exist:

(1) the majority of the lower bounds of the established biological escapement goal and sustainable escapement goal ranges are met or exceeded in five consecutive years and are expected to be met in the future years;

(2) if annual yields or harvestable surpluses are below the historical range, and the department recommends changing the stock of concern designation to a stock of yield concern.

5 AAC 05 is amended by adding a new section to read:

5 AAC 05.366. Yukon River Fall Chum Salmon Stock of Concern Management

Plan. (a) The purpose of the Yukon River Fall Chum Salmon Stock of Concern Management Plan is to provide the department with tools and guidelines for managing Yukon River salmon fisheries consistent with AS 16.05.258, 5 AAC 39.220, 5 AAC 39.222 and the Pacific Salmon Treaty. While Yukon River fall chum salmon are designated as a stock of management concern, this plan is intended to ensure run sizes at levels sufficient to meet established escapement goals, while also allowing for harvest opportunities in subsistence, sport, and commercial fisheries, consistent with AS 16.05.258.

(b) When Yukon fall chum salmon are designated as a stock of management concern, the department shall implement the Yukon River Drainage Fall Chum Salmon Management Plan described in 5 AAC 01.249 from July 13 through December 31.

(c) The department shall prohibit commercial fisheries in the Yukon River drainage from July 13 through December 31 when the projected run size is less than 550,000 fall chum salmon as specified in 5 AAC 01.249(5).

(d) The department shall restrict sport fishing for Yukon fall chum salmon in the Yukon River drainage until subsistence opportunities are provided.

(e) The department shall manage personal use fisheries in accordance with 5 AAC 77.171 - 5 AAC 77.174 if subsistence opportunities are provided.

(f) If the department determines that a harvestable surplus is expected to exceed 300,000 fall chum salmon, the department shall provide subsistence fishing opportunities consistent with precautionary management principles of 5 AAC 39.222 to achieve the drainage-wide or tributary-specific escapement goals.

(g) In addition to management measures specified in 5 AAC 01.249 and educational permits provided under 5 AAC 93.212, the department may relax subsistence fishery management measures in specific tributaries within the state if updated stock composition and run assessment data indicate areas where specific restrictions are no longer needed to ensure the established escapement goals will be met. (Eff. 6 / 17 / 2026, Register 258)

Chapter 21. Cook Inlet Area.

5 AAC 21.382(g) is amended to read:

(g) In the Upper Subdistrict of the Central District set gillnet commercial fishery,

(1) from June 20 through July 31 [JUNE 30], when the [PRESEASON] forecast of king salmon 75 cm mid eye to tail fork and longer is greater than 14,250 fish, including harvest and forecast error, the Upper Subdistrict [SET GILLNET] fishery may open to S04H CFEC permit holders [BE OPENED] as follows:

(A) the use of a beach seine, as described in 5 AAC 39.105(d)(6), is allowed as an alternative gear type for S04H CFEC permit holders;

(B) an S04H commercial set gillnet CFEC permit holder may operate not more than one beach seine;

(C) the maximum legal limit for a beach seine is 70 fathoms in length, 110 mesh depth, including border and chaffing strips, and three and one-half inch mesh size throughout; notwithstanding 5 AAC 21.332, a beach seine has no minimum length, depth, or mesh size requirements;

(D) fishing with a beach seine must occur from shore or waterline, with one end anchored on shore and the outside end set and retrieved back to the shore or waterline using a running line;

(E) openings will occur for two 12-hour periods per week, established by emergency order;

(F) retention of king and coho salmon is prohibited, except that a king or coho salmon that is mortally wounded or caught in a beach seine is subject to (i) and (j) of this section; in this subparagraph, "caught" means brought on board a vessel or removed from the water;

(G) the number of king or coho salmon released must be recorded on an ADF&G fish ticket under the disposition code for live release;

(H) a commercial dip net may not be operated within 600 feet of any part of a commercial beach seine, and a commercial beach seine may not be operated, in whole or in part, within 600 feet of any part of another commercial beach seine

(i) NINILCHIK RIVER MOUTH TO KASILOF RIVER MOUTH
(STAT AREAS 244–21, 244–22), THREE HOURS LATER THAN THE
SELDOVIA DISTRICT LOW TIDE;

(ii) KASILOF RIVER MOUTH TO KENAI RIVER MOUTH
(STAT AREA 244–31), FOUR HOURS LATER THAN THE SELDOVIA
DISTRICT LOW TIDE;

(iii) OPENING TIMES WILL BE BASED ON NOAA
CERTIFIED TIDE TABLES;

(2) FROM JULY 15 THROUGH JULY 27, WHEN THE INSEASON
PROJECTION OF KING SALMON 75 CM MID EYE TO TAIL FORK AND LONGER IS
GREATER THAN 14,250 FISH, INCLUDING HARVEST AND PROJECTION ERROR, THE
UPPER SUBDISTRICT SET GILLNET FISHERY MAY BE OPENED AS FOLLOWS:

(A) EACH SETNET PERMIT HOLDER MAY USE UP TO ONE SET
GILLNET THAT IS NOT MORE THAN 35 FATHOMS IN LENGTH AND 29
MESHES IN DEPTH;

(B) IS OPEN FOR NOT MORE THAN FOUR EIGHT-HOUR PERIODS;

(C) WITH A 48-HOUR CONTINUOUS CLOSURE PER WEEK,

GREATER THAN 14,250 FISH, ACCOUNTING FOR ANTICIPATED HARVEST,
PROJECTION ERROR AND INSEASON RUN STRENGTH, THE UPPER SUBDISTRICT
SET GILLNET FISHERY MAY BE OPENED AS FOLLOWS:

(A) EACH SETNET PERMIT HOLDER MAY USE UP TO ONE SET
GILLNET THAT IS NOT MORE THAN 35 FATHOMS IN LENGTH AND 29
MESHES IN DEPTH;

(B) IS OPEN FOR NOT MORE THAN TWO EIGHT-HOUR PERIODS;

(C) WITH A 48-HOUR CONTINUOUS CLOSURE PER WEEK,
BEGINNING BETWEEN 7:00 P.M. THURSDAY AND 7:00 A.M. FRIDAY;

(D) FISHERY OPENINGS WILL BE BASED UPON SELDOVIA
DISTRICT TIDE TABLES BY SECTION AS FOLLOWS:

(i) NINILCHIK RIVER MOUTH TO KASILOF RIVER MOUTH
(STAT AREAS 244-21, 244-22), THREE HOURS LATER THAN THE

SELDOVIA DISTRICT LOW TIDE;

(ii) KASILOF RIVER MOUTH TO KENAI RIVER MOUTH
(STAT AREAS 244-31, 244-32), FOUR HOURS LATER THAN THE
SELDOVIA DISTRICT LOW TIDE;

(iii) KENAI RIVER MOUTH TO BOULDER POINT (STAT
AREAS 244-41, 244-42), FIVE HOURS LATER THAN THE SELDOVIA
DISTRICT LOW TIDE;

(iv) OPENING TIMES WILL BE BASED ON NOAA CERTIFIED TIDE
TABLES];

(2) [(4)] in the Upper Subdistrict set gillnet commercial fishery, notwithstanding the provisions of 5 AAC 21.365 [,] and 5 AAC 21.360(c)(1)(B), (2)(B), and (3)(B), commercial fishing periods will be based on the abundance of sockeye salmon returning to the Kenai and Kasilof Rivers;

(3) from [(5) FROM] June 20 through July 31, [;]

(A) [ALLOW FOR] the use of dip nets **is allowed** as an alternative gear type for holders of **an** [A] S04H commercial set gillnet CFEC permit;

(B) openings may occur outside of specified openings in this section based on abundance of sockeye salmon from 7:00 a.m. - 7:00 p.m. on Monday, Tuesday, Wednesday, Thursday, and Friday, unless closed by emergency order;

(C) **an** [A] S04H commercial set gillnet CFEC permit holder may operate not more than four dip nets at a time, **and** each dip net must be operated by either the permit holder or an **ADF&G** [ADFG] licensed crewmember;

(D) retention of king and coho salmon is prohibited, except that a king salmon that is brought aboard the vessel or to shore is subject to **(i) and (j)** [(i) — (j)] of this section;

(E) fishing with a dip net may occur from a vessel or from shore; fishing from shore must occur at the location of a shore fishery tract identified in the recorded plat for that lease under AS 38.05.082 or City of Kenai shore fishery lease; nothing in this subsection affects or changes the terms or conditions of a lease and its lessee under AS 38.05.082 or a City of Kenai shore fishery lease and its lessee;

(F) the number of king or coho salmon that are released must be recorded on an ADF&G fish ticket under the disposition code for live release.

5 AAC 21.382 is amended by adding a new subsection to read:

(n) If the forecast or inseason projection of king salmon 75 cm mid eye to tail fork and longer is less than 14,250 fish, including harvest and forecast error, the commissioner may issue not more than 10 cost-neutral commissioner permits under the authority of AS 16.05.050(a)(9) for the beach seine gear type to S04H salmon permit holders registered in the Upper Subdistrict. (Eff. 6/8/2024, Register 250; am 7/10/2025, Register 255; am 6 / 17 / 2026, Register 258)

Chapter 96. Local Fish and Game Advisory Committees and Adoption of Fish and Game Regulations.

5 AAC 96 is amended by adding a new section to read:

5 AAC 96.621. Board of Fisheries traditional knowledge policy. (a) The Board of Fisheries will incorporate local knowledge and traditional knowledge as an aspect of best available science to inform Board of Fisheries regulation adoption.

(b) In this section,

(1) "local knowledge" means a way of knowing developed from the observations and personal and shared experiences of people living, working, harvesting, and processing fish or game in a specific place; "local knowledge" may be obtained rapidly rather than generationally;

(2) "traditional knowledge" means a way of knowing that is unique to a given culture or society, often through language, that encompasses a worldview that defines specific relationships between humans and nonhuman attributes of the world; "traditional knowledge" includes

(A) knowledge that derives from personal experiences and the cumulative experiences of a person's forbearers, including generational knowledge; and

(B) knowledge that is characterized by a long time scale that is local in scope and that may provide a counterpoint to more broad-based, scientifically produced knowledge. (Eff. 6 / 17 / 2026, Register 258)
