We have owned the home for approximately 9 years and I have been a Juneau resident for 40 years. We spent a great amount of effort preparing our Horse Island home in preparation for our retirement. We greatly anticipated moving to the island and taking up a more rural life style. In the summer of 2012 (our first year of retirement) we noticed a dramatic increase in the commercial crabbing in the very small channel between Horse and Colt Islands and Admiralty Island. This is the area where most of the Horse Island boats are moored. For us, this had several negative impacts. First there have been crab pot floats within 50 feet of where we moor our boat along with dozens of other floats making transiting the area more restrictive. My grandkids use our 16 foot skiff in that area to fish and explore, making it a bit more congested and dangerous. My hopes for personal use crabbing in the area is shot after the commercial season starts as they take every legal crab in the area. I just pull my couple of pots. For more than 40 years, we, Lou and Nancy Barr, have lived on the Juneau shoreline about halfway between Point Louisa and Lena Point. During that time, the area in front of our house has been open to commercial Dungeness crab fishing while adjacent nearshore areas to the southeast and northwest have been closed to that fishery. In spite of the fact that the 2.5 mile sector adjacent to our residence has been open to the fishery, no commercial pots had been set here until the last two years. During the long years of our residency here, we, neighbors, friends and others have taken occasional Dungeness crab from adjacent waters for personal use. How, however, there is a conflict between commercial and personal use for the resource. We are writing in support of PROPOSAL 77-5 AAC 32-150, a proposal to place the 2.5 mile stretch in question under the same status as adjacent waters, thereby closing it to commercial Dundgeness fishing.

As a long-time diver who previously used diving as a tool in his work as a biologist with National Marine Fisheries Service, Lou has traversed much of the underwater area of the 2.5 mile sector in question. In that area, he found little suitable underwater habitat for Dungeness crab; instead he observed occasional isolated areas occupied by a limited number of crabs. His underwater observations were consistent with the fact that in the last two years we have seen commercial vessels set pots in strings along much of the shoreline, pull the pots, then reset fewer pots in more limited areas. This year we observed that even commercial pots set in limited areas were sometimes left to soak for as much as two weeks, something that would probably not the case if sets had been reasonably productive. Long sets in limited areas would seem to support the underwater observations that Dungeness crabs are not abundant in the area. If that is the case, then the potential value of the resource to a commercial fishery is probably minimal. With the ability of the resource in the area to sustain a continuing commercial harvest questionable, best use of the resource would, it seems to us, be achieved by closing the 2.5 mile stetch to commercial crabbing, thereby placing it in the same status as adjacent areas, while continuing to permit personal use like that which has been sustained in the area for the last 40 years or more.

This is like many other proposals in the booklet seeking to favor sport crabbing over commercial. They should all be rejected by the board because there is no consevation concern for Dungeness Crab in SE. In fact catches are at very high levels. The Whale Pass proposal is the worst of the bunch because it presents absolutely no data on the status of crabs in Whale Pass, or catch per effort statistics for either sport or commercial pots. It states nothing about who might be negatively affected by such a closure, Or for that matter who might be positively affected, if anyone. It is at best simply the opinion of one or several sport/subsistence fishers that they will catch more crabs by closing commercials out. How many crabs do they need or want? What are they taking now? Proposals like these seem to imply that the commercials can simply go someplace else to catch their crabs (if the proponents even care about the livelihood of the commercials). But if every community in SE AK gets a special sport/subsistence area of its own, the the commercials in SE really take a hit. Crabs are not everywhere, which means that there will be some competition among the groups for the hot spots. Since commercial crabbing in Whale Pass is at most about a two month effort in June and July, the sport/subsistence users still have some ten months a year of unimpeded access (not withstanding their competion with one another which is probably the more real competition than that with the commercials). Is it fair that they get 100% access, to the detriment of an industry that provides jobs on the boats and in the processing plants, and a fine seafood product to others who don't fish with sport/subsistence

We are the submitters of these two proposed closures. After several decades of setting a pot or two in these areas without commercial use, 2012 was the first year we saw commercial use. That year, the same commercial user set pots in both areas. 2014 saw commercial use again. It is likely other commercial users also crabbed the areas and we just didn't see their pots.

All of the south Lena shoreline, 2.5 miles, is residential housing. Having this area open to commercial when the waters to the North (closed 2000) and to the South (1980) are closed defies logic. Homeowners should be able to row a dingy out, set a pot or two, and expect to harvest a few dungies. Once the commercial boats string the waters with pots that option is severely limited.

The same issue is prevalent at Horse and Colt. Numerous cabin owners on both islands enjoy setting a pot or two. Once the commercial boats crabbed this area starting in 2012 the ability to catch crabs plummeted.

While these pubic waters are open to commercial use it is bewildering why commercial crabbers would even set pots in these areas knowing full well that their harvest will effectively end the small harvest enjoyed by the local upland users.

While commercial crabbers need sufficient area to crab and with larger boats are better able to crab areas away from these two proposed closures, the closure of these two area is unlikely to impact their total catch to any significant degree. Closing these two areas provides for a much higher degree of success for upland land owners.
