V. Address Concerns from Board of Fish Meeting: Motion to readdress 147 made by Ben. Seconded by Gary. The concerns of fishing opportunity and subsistence were discussed. They are simultaneous, yet conflicted concerns as the solutions to each. Some members were uncomfortable that the 25k was through the 15th of September.

Gary made a motion to amend 147 to Rewrite AAC 15.357 (b)(3)(B) to read: (B) the department shall manage the commercial fishery to allow for the passage of at least 50,000 sockeye salmon above the Chignik River weir, in addition to the late-run sockeye salmon escapement needs, to provide an inriver harvestable surplus above the Chignik River weir in August and September of at least 25,000 fish in August and 25,000 fish from September 1 through September 30.

Gene seconded. Unanimous consent was requested. Amendment passed.

Ben made a motion to readdress 154 made by Ben, seconded by Gene. CRAA stated that the department was opposed to this proposal and that they have difficulty with differentiating salmon size. Also, the Gulf stocks are generally depressed. One member suggested releasing kings voluntarily. Concern was shared that the commercial fishery could be shut down for the king escapement. Again, there were simultaneous concerns of lack of escapement/run failure and economic impacts of losing fishing opportunity any solutions for one concern were conflicted against the other. It was pointed out that it is the departments job to set escapement goals rather than the AC. Ben made a motion to amend the December AC amendment striking the minimum escapement goal of 2000 recommended at the December 12<sup>th</sup> meeting but maintaining 7lbs or less to define "jack chinook". Austin seconded. Stephen called question. Roll call vote for amendment. Support- 8 Oppose-2
