Request for Committee Nominations

Alaska Board of Fisheries Special Committee on Nushagak-Mulchatna King Salmon Fishery Management Plan

(Released January 31, 2019)

At its 2018 Bristol Bay Finfish meeting, the Alaska Board of Fisheries (board) heard testimony from Nushagak sport and commercial fishing stakeholders regarding Proposals 41 and 42 seeking to create a mechanism that would pair restrictions on both the sport and commercial fishery for the purposes of king salmon conservation.

As a result of this discussion, the board created a special committee to review the fisheries and provide recommendations to the board on a comprehensive solution. A charge statement for the committee is listed under Board policy 2018-291-FB with related information in record copies 80 and 84 from the Bristol Bay meeting.
