## Alaska Board of Fisheries to hold three meetings in October

Work Session, Joint Protocol Committee Meeting, and the Chignik, Alaska Peninsula, Aleutian Islands, and Bering Sea Pacific Cod Meeting

The Alaska Board of Fisheries (board) will meet October 15-19, 2018, at the Egan Civic & Convention Center, 555 West 5<sup>th</sup> Avenue, Anchorage, Alaska to hold three consecutive meetings.

## **Board of Fisheries Work Session**

From October 15-16, beginning at 8:30am, the board will hold its 2018/2019 work session. No regulatory action is taken at this meeting. Agenda topics may include: electing officers, accepting agenda change requests (ACRs), reviewing petitions, meeting organization, creating board generated proposals, establishing committees for the 2018/2019 meeting cycle, setting locations and dates for the 2020/2021 meeting cycle, informational reports, executive sessions and administrative issues that come before the board. The board is also holding a separate session on Alaska salmon hatcheries (see below).

The board's 2018 ACRs are available for review on the board's website. ACRs are submitted by the public, advisory committees, and agencies seeking regulatory change for regions and species not up for review in the current meeting cycle. The board accepts ACRs as proposals for the 2018/2019 meeting cycle based on guidelines in 5 AAC 39.999 which include the ACR is:

- For a fishery conservation purpose or reason.
- To correct an error in a regulation.
- To correct an effect on a fishery that was unforeseen when a regulation was adopted.

This includes reports by the Alaska Department of Fish and Game (ADF&G), followed by a townhall style public forum moderated by the board with open public participation. Joint Protocol Committee Meeting with the North Pacific Fishery Management Council On October 17, beginning at 9:00am and continuing at the Egan Center, the board's Joint Protocol Committee (committee) will meet with its counterparts at the North Pacific Fishery Management Council (council). This inter-agency committee meets as needed to discuss issues of mutual interest. The committee last met in May 2014.

The committee intends to discuss items including the status of the council's fisheries management plan development for Cook Inlet salmon in federal waters, the status of state management of Chinook salmon in Southeast Alaska, and Bering Sea Pacific cod abundance and management issues. More items may be discussed as determined by the committee.
