Synopsis

- King salmon adopted as SOC at October work session.
- Criteria Failure to meet the BEG 5 of 6 years, despite management action.
- Department tasked with developing an action plan.



Definitions

Stock of Management Concern

"means a concern arising from a chronic inability, despite the use of specific management measures, to maintain escapements for a salmon stock within the bounds of the SEG, BEG, OEG, or other specified management objectives for the fishery."



Definitions

Chronic Inability

"chronic inability means the continuing or anticipated inability to meet escapement thresholds over a four to five year period, which is approximately the generation time of most salmon species."








King Salmon Harvest

Conditions for Delisting

Action Plan pages 20 - 21

Delisting — If the lower bound of the BEG range is met or exceeded in three consecutive years or four out of six consecutive years and the department is expecting to meet the goal in future years, the department will recommend removing Chignik River king salmon as a stock of management concern at the first Chignik board meeting after this condition is met.

Management measures could be relaxed in specific areas –

- If updated data indicates areas where restrictions are no longer needed to ensure the escapement goal is met.
- In the event that 2 consecutive years of escapements are near the upper bound or above the BEG range, management restrictions may be relaxed or set aside using EO authority.
