<u>Chairman GASH, Ken Chase</u>- We would like to honor the Kalskag folks and then have a trail that we can enforce and take on the small area to connect with the new boundary line. The area we would like to see is below Whitefish Lake that connects over into 19A, south of Whitefish Lake.

Bruce, GASH- No, we wouldn't have a problem for how ever the boundary line.

<u>Chairman LKAC, James Charles</u>- The purple line is what we made last November. We have to think of the future too, because our generations would want to hunt in these areas. They travel a lot and we have to think about the moose moratorium. In the future they may be able to open like the Lower Yukon too and who owns the land. When people are hunting, even before they go and start traveling. Down in my area, we stay away from where it is closed and a lot of work to hunt in the area please think about the future.

<u>Greg Roczicka, Bethel</u>- Enforcement purposes we ran it straight through the lake. It was used to make a clear boundary.

<u>Chairman CKAC, Lisa Feyereisen-</u> The land use is being trashed and why would it be all of a sudden such in Unit 18. It is an issue that has been addressed? TKC has their trespassing starts from mud creek. They do not want the straight line to have it removed.

<u>Earl Samuelson, LKAC-</u> How would it change the hunting regulations. If that line is no fly zone. Phillip Perry, ADFG-

Roger Seavoy, ADFG- When you pick a boundary, 8 years people haven't been able to hunt the Holitna area, due to no moose. When the boundary line will have to change to match those lines.

<u>Kevin Carter, Bethel-</u> Would it be possible for the State to make a 10 mile buffer zone? These proposed changes this would be in acted in July 1st. 2014-2015 will be a new book.

<u>Jackson Williams, LKAC Akiak-</u> We have a resolution from back 3-4 years that was brought forth from our IRA Tribal Akiak Council. In my personal view, back in the day prior to the trespassing limits for Unit 19 area or up to mud creek. A lot of us stopped hunting up there anymore, because of the trespassing limits. Since I know there will be a lot of people from Akiak that wouldn't be able to hunt in that area, that is why we oppose the proposal.
