Travis Ellison, ADFG Area Biologist Schedule for subsistence harvest of King Salmon Closes June 1 opens around June 20 for maybe 8 hours Closed until 1st of July opening around July 4th for open 24/7 subsistence fishing for chum and reds. Subsistence user want a known schedule of fishing Commercial fishing around mid July.

All fishing will be closed for Chum and Red's that run with the Chinook. ADFG doesn't want people fishing on top of a peak run with the current outlook. We are planning on shortening nets to 25 fathoms from 50 fathoms which will allow us to open up the fishery for longer periods.

Under this type of fishing that all king salmon will have to be released alive, opposed to gill nets. We can provide more opportunity for chum and reds. Greg Roczicka- Entertains the suggestion of purse seins. Is that allowed during closures for Chinook? Travis Ellison, ADFG- Emergency proposal to allow dip netting. There isn't much of a test for purse seins as dipnets. They are more expensive gear and I don't know how many people will be getting that gear? They are allowed under the state regulations for beach seins and we are going to specify the gear during Chinook conservation. Allen Joseph- Letting know that villages may look at illegal protest fishing, would like to see a couple open subsistence periods open in early June 1st to June 20. Travis Elison, ADFG-Looking at subsistence runs at 70,000 total fish with only a 5,000 fish surplus. Closure to July 15 if early Chinook fishing is allowed to get total Escapement met for Chinook salmon. Ross Boring- What education activities are you engaged in at this time. Greg Roczicka- Request from village for 804 reviews which would only allow with a tier 2 federal fishery, looking at Tier 1 for active fish camps around 500 fish camps. If state department allows the Federal system to look at this proposal. Question has been called. Motion to Support- <u>Unanimous Consent</u> (Support Dipnet Emer. Petition)
